1. Appointment as Scrutinizer

We were appointed as the Scrutinizer for the remote e-voting as well as the e-voting by the Members at the 19th Annual General Meeting ("AGM") of Sirca Paints India Limited (hereinafter referred to as 'the Company') held on Thursday, 29th August, 2024 at 12.30 p.m. (1ST) through Video Conferencing ("VC") / Other Audio-Visual Means ("OAVM").  - a) Prior to the dispatch of Notice, on 30th July, 2024, pursuant to the relevant circulars issued by the Ministry of Corporate Affairs (MCA) for holding the AGM or other general
