Summary of the proceeding of the Meeting of Unsecured Creditors of the Company.

The Meeting of Unsecured Creditors (Meeting) of the Company was held on Monday, 29th December, 2025 at 12:30 p.m. IST through Video Conferencing ("VC")/Other Audio Visual Means ("OAVM") pursuant to the order of Hon'ble National Company Law Tribunal, Mumbai Bench dated 4th November, 2025. Shri. Ashok Jalan, Senior President cum Director, chaired the meeting ("Chairperson") of the Unsecured Creditors of the Company and Shri. Mahipal Thakur, Company Secretary assisted the Chairperson in conducting the said meeting.

The Company Secretary introduced Directors, Auditors, Scrutinizer and other dignitaries present at the meeting and welcomed the Unsecured Creditors. He informed the Unsecured Creditors that the meeting was being held through VC/ OAVM, pursuant to the order passed by the Hon'ble NCLT and in compliance with the circulars issued by the Ministry of Corporate Affairs, Government of India and the Securities and Exchange Board of India.

The Company Secretary also provided various details to the Unsecured Creditors with respect to quorum, Q&A, remote e-voting, e-voting at the meeting, etc. The Unsecured Creditors were informed that pursuant to the order of the Hon'ble NCLT, Shri. The Chairperson addressed the Unsecured Creditors present at the meeting and briefed about the Scheme of Arrangement between Siyaram Silk Mills Limited and its shareholders ("Scheme"), under Section 230 and other applicable provisions of the Companies Act, 2013.

The Chairperson invited the Members to express their views and ask questions. None of the Unsecured Creditor had asked any question/raised any query.



The Chairperson Shri Ashok M. Jalan informed the Meeting that the Scrutinizer's Report will be submitted/displayed within 2 (two) working days of the conclusion of the Meeting.
