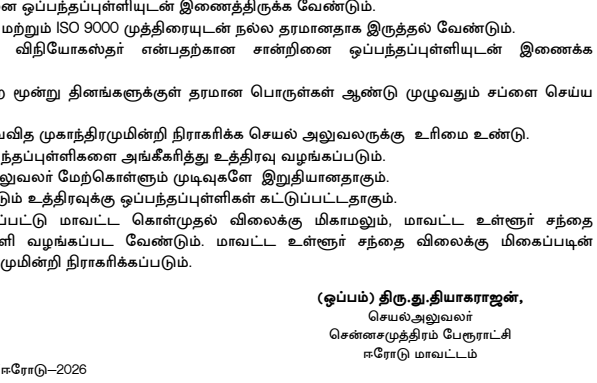

Minister Muthusamy lays foundation for flower market complex in Gobi

Erode, Jan. 6: Housing, Prohibition and Excise Minister S. Muthusamy laid the foundation stone for the construction of a Flower Market Commercial Complex in Gobichettipalayam Municipality of Erode district. He also inaugurated the municipal and Highways Department entrance arch by naming it "Perunthalaivar Kamarajar Arch."

Speaking on the occasion, the Minister said that Tamil Nadu Chief Minister M.K. Stalin has been announcing and effectively implementing new schemes across all departments to benefit people from all sections of society.

Under the Kalaigarn Urban Development Scheme 2025-2026, a new flower market commercial complex is being constructed in

Gobichettipalayam Municipality at an estimated cost of Rs. 2.64 crore. The building will cover an area of 7,000 square feet and will include 21 modern shops, along with facilities such as vehicle parking and toilets, to ensure convenience for the public and traders. The foundation stone for this project was laid today.

The Minister further stated that, as per the Chief Minister's instructions, a daily vegetable market commercial complex has already been established in Gobichettipalayam at a prime central location. This vegetable market has been named after Language Agitation Martyr G.P. Venkidu, who is widely respected not only in Gobi but also among people from surrounding areas.

He also highlighted that various road-widening works are being carried out across Erode District to ease traffic congestion. As part of this initiative, the old entrance arch on the western side of the Gobichettipalayam-Sathyamangalam State Highway, which serves as a key identity landmark for the town, was renovated and officially named "Perunthalaivar Kamarajar Arch." The Minister described the occasion as a moment of pride and happiness.

The event was attended by District Collector Kandasamy, Anthiyur MLA A.G. Venkatachalam, Municipal Council Chairman Nagaraj, Gobi Municipal Commissioner Mangaiyarkarasan, and other officials from various departments.
