Q3 FY26 Business Updates

During Q3 FY26, Smarten Power Systems Limited continued executing on its long-term strategy of building a **vertically integrated renewable energy and energy storage company**.

The Company achieved a 26.4% year-on-year increase in total sales in December 2025.

While near-term revenue trends show volatility, particularly across quarters, the underlying operating actions taken over the past 12–18 months—**backward integration, capacity expansion, R&D strengthening, and service-led distribution—are now firmly in place** and beginning to influence outcomes.

We have introduced Lithium-battery-compatible inverters ahead of peers with advanced hybrid inverter platforms under development. These inverters are non-commodity, high margin products and are expected to be launched by Q3FY27 with assistance from our internal R&D team.

We have started delivering 4000 Solar Power Conditioning Units (PCUs) under a newly executed government tender order via a third party. These PCUs are supplied along with Smarten's proprietary remote monitoring software, enabling real-time performance with IOT and tracking of installed solar systems. This order is distinct from our regular distributor-driven retail business and we plan to get into more such orders in the future.

Proven Ability to Compete with Large Brands

The company competes with established players and has successfully defended its market share over several years despite the presence of large legacy brands.

Our team of 7 R&D engineers plays a critical role in driving product innovation and technological differentiation across our portfolio. The team focuses on in-house design and development of power electronics, including inverters, solar PCUs, charge controllers and upcoming hybrid inverter platforms, enabling faster time-to-market and customization for diverse applications.

Over the last six months alone, the company has added 31 new distributors, taking its network to over 400 distributors across India.

A key differentiator is our strong after-sales infrastructure, including a dedicated 24×7 WhatsApp-based resolution system supported by 50+ service points nationwide.

The company enjoys a competitive edge driven by superior technology, strong service capabilities, product customization enabled by over 50+ years of combined promoter experience in the power electronics space, and deep local market understanding.

Additionally, the company has a dedicated **lithium-ion battery assembly area** at its existing Gurugram facility, which will be further expanded at the new Jhajjar plant by April 2026, with all existing electronics (including inverters, PCUs and hybrid systems) already **fully lithium-compatible**.
