He said products that idolise criminal figures pose significant risk to society by promoting a distorted image that could influence young minds negatively.



ised that there would be no construction on Mahalakshmi racecourse land, which would be retained as open space in its existing condition. In addition, Sena (UBT) announced that the Old Pension Scheme will be implemented for govt employees.

In keeping with the stance announced at MVA's BKC rally, Uddhav said under MVA regime, the state legislature will pass a resolution to take the reservation limit above 50% and put pressure on the Centre in this regard. Sena (UBT) will also establish a Gig Workers Welfare Board for registration, insurance, and social security of app-platform-based gig workers in the state.

In addition to free bus travel for women announced by Congress in MVA's five guarantees on Wednesday, Sena (UBT) said it will pursue the issue of free travel for women in local trains with Centre.

Further, the manifesto stated, "Local self-govt elections will be held promptly, respecting constitutional democracy. MVA will cancel the allotment of land, TDR, and other inappropriate decisions and related GRs issued by the Mahayuti govt. We will establish a separate ministry for micro and small enterprises. We will establish a separate department to empower women self-help groups."

Meanwhile, Maharashtra BJP chief Chandrashekhar Bawankule took a dig at Uddhav for releasing manifesto from home, claiming Sena (UBT) member was focusing more on his family and neglecting the wider community.


