Bengal tweaks OBC list & ousts 65 Muslim groups

Kolkata: The Bengal assembly on Monday passed two amendment bills aimed at overhauling the legal framework governing reservations for OBCs, specifying 66 communities (54 Hindu and 12 Muslim communities) outside the SC and ST categories will be eligible for OBC quota. The new framework removes 65 Muslim sub-groups (from the previous TMC govt-set framework) and nine Hindu sub-groups.

The previous state govt had revised the OBC list, first to 113 sub-groups — 77 Muslim and 36 Hindu sub-groups. In 2025, this was struck down by the Calcutta high court. Govt then revised this to 140 sub-groups — 77 Muslim and 63 Hindu sub-groups. The HC had put a stay on this, but the Supreme Court had vacated the stay. Now the OBC classification has reverted to the pre-Trinamool 66 OBC sub-groups.

The bills passed on Monday also restored greater powers to the West Bengal Commission for Backward Classes while scrapping the statutory recognition accorded to a list of OBC communities under the previous Trinamool govt. The West Bengal Backward Classes (Other than Scheduled Castes and Scheduled Tribes) (Reservation of Va-

CM vows 'goon-free Bengal', House passes two bills

CM Suwendu Adhikari on Monday promised a "goon-free Bengal" and vowed to make "rioters homeless" as the assembly passed two bills providing for preventive detention of habitual offenders for up to a year and confiscation of properties to recover losses caused during riots and mob violence. Adhikari said the laws target only anti-social elements, not those engaged in politics, social service or religious work, and cited the anti-CAA protests, unrest over remarks by BJP's former spokesperson Nupur Sharma and violence over the Waqf Amendment Act to justify the measures. cancies in Services and Posts) (Amendment) Bill, 2026, and the West Bengal Commission for Backward Classes (Amendment) Bill, 2026 were introduced by state backward classes welfare minister Gaurishankar Ghosh and passed after a division in the House.

The amendments seek to undo changes introduced by the TMC govt in 2012. BJP had repeatedly alleged that the TMC govt extended OBC benefits disproportionately to Muslim communities while overlooking several socially and

educationally backward Hindu groups. Under the amended law, the state govt, in consultation with the West Bengal Commission for Backward Classes, will determine the percentage of reservation for OBCs and may revise it periodically. However, the overall reservation ceiling will remain capped at 50%. Govt will also be empowered to classify OBC communities into different categories based on degree of backwardness following the commission's recommendations.

The amendment to the West Bengal Commission for Backward Classes Act, 1993, allows individuals to apply for inclusion in the OBC list and to raise objections regarding over-inclusion or under-inclusion of communities. The commission's recommendations on such matters will be binding on the govt. In May 2024, the Calcutta HC cancelled all OBC certificates issued after 2010, observing that the process adopted by the state govt for inclusion of communities in the OBC list was legally unsustainable. After assuming office in May, the BJP govt reduced reservations for OBCs to 7% from the earlier 17% through a notification reservation for 66 OBC classes in the state. While the tenure of the commission members will continue to be three years, the state govt will determine the tenure of the member secretary, who will be a serving govt official.

2 mths after rape of 3-yr-old in Maha, 65-yr-old gets death

Pune: Two months after a three-year-old girl was raped and murdered at Nasrapur in Maharashtra's Pune district, a fast-track court sentenced Monday 65-year-old contract worker Bhimrao Kamble to death after a speedy conviction based on the "last-seen" theory and "an unbroken chain" of circumstantial evidence report Vishwas Kothari, Alim Shaikh & Kanwardeep Singh. "Now, go to the gallows," special judge S R Salunkhe said, ruling that the case belonged to the rarest-of-rare category given its "manner, motive and magnitude".

The court noted that Kamble, a father of married daughters and a son, had a history of sexual crimes and that the May 1 rape-murder for which he had been convicted was "a cold-blooded, unprovoked and premeditated act". Investigators found out that Kamble wooed the child to a nearby cowshed on the pretext of showing her a newborn calf when she was playing outside her grandmother's home. He then raped and killed her, hiding the body in the cowshed.

Haryana to execute 32-yr-old deal, give Raj Yamuna water

New Delhi: Haryana and Rajasthan on Monday signed an agreement that allows the latter to get water from the Yamuna Canal through three underground pipelines from July to Oct every year under the 1994 Memorandum of Understanding (MoU) on the sharing of utilisable surface waters of Upper Yamuna Basin.

The agreement, signed here in the presence of Union Home and Cooperation Minister Amit Shah and Jal Shakti minister C R Patil, will facilitate supply of drinking water to the districts of Sikar, Churu and Jhunjhunu in Rajasthan, as well as Bhiwani and Fatehabad areas in Haryana.

The 32-year-old agreement could not be implemented till now because of the absence of a canal system to supply water to Rajasthan. The move will now allow the implementation of Yamuna Water Project.

Stating that the agreement had resolved the three-decade-old water-related problem faced by people of Haryana and Rajasthan, Shah said the agreement is an excellent example of the mantra 'Solution Through Dialogue' given by Prime Minister Narendra Modi.

"This agreement demonstrates that if states move forward with the spirit of cooperative federalism, even a problem persisting for three decades can be resolved easily... It's a win-win situation for both the states," said Shah. Rajasthan chief minister Bhajan Lal Sharma and Haryana chief minister Nayab Singh Saini were also present on the occasion.

Shah said water that earlier went to waste will now quench people's thirst and will be stored in large ponds to recharge the groundwater level. Approximately 580 million cubic metres (MCM) of water will be supplied from Yamuna Canal to Rajasthan through three underground pipelines having a diameter of more than 3.6 metres.

SC junks early hearing on Vikas Yadav's bail plea

New Delhi: The Supreme Court on Monday refused an early hearing on a bail petition by Vikas Yadav, in jail for the sensational murder of Nitish Katara in 2002, to finalise the sale of a parcel of land to raise Rs 54 lakh he is required to pay as a fine in addition to serving a 25-year sentence.

Senior advocate S Nagamuthu told a bench of Justices M M Sundresh and Sheel Nagu that after a lot of effort, a buyer had agreed to acquire the land and wanted the sale deed to be registered on Friday. This would require Yadav's release on interim bail and help him raise the Rs 54 lakh he has to deposit as a fine, he added.

When the bench said there was no urgency in hearing Yadav's plea, Nagamuthu said the man had been behind bars for 24 years without remission and deserved leniency from the court. The bench declined and said a coordinate bench of the SC had fixed his pending application, which was on similar lines, for hearing on July 21. "We cannot alter the date during partial working days," it said. On Sept 26 last year, a bench of Justices Sundresh and S C Sharma had upheld a Delhi HC order declining to extend the interim bail of 54-year-old Yadav, who had sought bail to get married and raise the fine amount.

UP college principal kills clerk, drives with body

Agra: A principal of a govt-aided inter college in Etah district was arrested early Monday for allegedly strangling a clerk to death after hitting his face with a brick at the campus over a paperwork feud. Police said, Krishna Kumar Pandey (58) was found driving around the UP district with the body of Rahul Pandey (35) in his vehicle in order to dump him in Kasganj. TNN

Govt lifts petrol, diesel curbs for commercial users

New Delhi: Rolling back yet another emergency measure introduced to ensure equitable distribution of fuel during the West Asia conflict, govt Monday decided to lift restrictions on the sale of petrol and diesel to commercial users from retail pumps from July 1. As energy supplies improve with the reopening of the Strait of Hormuz and the situation stabilising, govt has also decided to remove the 200-litre-per-consumer cap on diesel sales that was imposed to curb hoarding and black-marketing of the fuel. The order came days after ministry of petroleum and natural gas restored supplies of commercial LPG cylinders to pre-conflict levels. The temporary restrictions on sale and distribution of petrol and diesel to commercial users, such as transport operators and industrial units, were imposed on June 12. TNN
