'एफएनटीए'चा करार ऐतिहासिक

पंतप्रधान नरेंद्र मोदी यांचे प्रतिपादन : ठाम वचनबद्धतेचे प्रतीक

नवी दिल्ली, ता. ६ (पीटीआय) : 'ईशान्य भारतातील नागालँड राज्यासाठी करण्यात आलेला त्रिपक्षीय करार 'ऐतिहासिक' असून, हा करार शांतता, प्राप्ती आणि सर्वसमावेशक विकासाबाबत केंद्र सरकारच्या ठाम वचनबद्धतेचे प्रतीक आहे. हा करार 'ईस्टर्न नागालँड'च्या

विकासाला विशेष गती देणारा आहे, असे प्रतिपादन पंतप्रधान नरेंद्र मोदी यांनी शुक्रवारी केले. पूर्वी नागालँडच्या मागण्यांचा विचार करून केंद्र सरकार, नागालँड सरकार आणि ईस्टर्न नागालँड पोपल्स ऑर्गनायझेशन (ईएनपीओ) यांच्यात 'फ्रंटियर नागालँड टेरिटोरियल ऑथॉरिटी (एफएनटीए)

त्रिपक्षीय करार करण्यात आला आहे. हा करार गुरुवारी नागालँडचे मुख्यमंत्री नेइफियु रिओ आणि केंद्रीय गृहमंत्री अमित शहा यांच्या उपस्थितीत करण्यात आला. त्याबाबत पंतप्रधान मोदी यांनी 'एक्स' वर पोस्ट करत माहिती दिली. "हा करार निश्चितच ऐतिहासिक असून विशेषतः पूर्वी नागालँडच्या विकासाच्या प्रवासाला नवे चळवळ देणारा ठरेल," असे प्रतिपादन

पंतप्रधान मोदी यांनी त्यांच्या पोस्टमध्ये केले आहे. या करारामुळे ईशान्य भारतातील नागरिकांसाठी संधी आणि समृद्धीचे नवे मार्ग खुले होतील, असा दावाही त्यांनी केला. ईशान्य भारतात शांतता, प्राप्ती आणि सर्वसमावेशक विकासासाठी आमचं अटळ बांधिलकी यातून दिसून येते, असेही पंतप्रधानांनी नमूद केले.

करारामुळे नागालँडमधील सहा जिल्हांसाठी 'फ्रंटियर नागालँड टेरिटोरियल ऑथॉरिटी'ची स्थापना होणार आहे. तसेच ४६ विषयांबाबतचे अधिकार या नव्या प्राधिकरणाकडे सोपविण्यात येणार आहेत. यामुळे पूर्वी नागालँडच्या प्रशासकीय स्वायत्ततेला चालना मिळणार असून स्थानिकांना निर्णयप्रक्रियेत सहभाग घेता येणार आहे.



पीडितेस कोर्टाकडून गर्भपाताची परवानगी

प्रजनन स्वातंत्र्यास महत्त्व

उच्च न्यायालयाने जे. जे. रणालयाला त्या अल्पवयीन पीडितेची तपासणी करून ती या प्रक्रियेसाठी शारीरिकदृष्ट्या योग्य आहे की नाही, हे निश्चित करण्याचे निर्देश दिले होते कारण गर्भधारणेला २७ आठवडे पूर्ण झाले होते. उच्च न्यायालयाने सादर केलेल्या वैद्यकीय अहवालात स्पष्टपणे नमूद करण्यात आले आहे की, 'पीडितेवर गर्भपात प्रक्रिया केली जाऊ शकते आणि गर्भधारणा पूर्ण कालावधीपर्यंत सुरु ठेवल्यास अल्पवयीन मुलीला मानसिक आणि शारीरिक आघात होईल.'

सर्वोच्च न्यायालयाच्या न्या. वी. व्ही. नागराज आणि न्या. उज्जल भुयान यांच्या खंडपीठापुढे अधिवक्ता शान्तनू मकरंद अडकर यांनी अल्पवयीन मुलीच्या आईच्या वतीने युक्तिवाद केला आणि गर्भधारणेच्याबाबतीत आईच्या प्रजनन स्वातंत्र्याचा मुद्दा मांडला, तसेच अल्पवयीन मुली स्वतः गर्भधारणा संपुष्टात आणण्यास इच्छुक असल्याचे सांगितले. सर्वोच्च न्यायालयाने उच्च न्यायालयाचा आदेश रद्द करताना सांगितले की, 'गर्भवती मुलीच्या प्रजनन स्वातंत्र्याला योग्य महत्त्व दिले पाहिजे, विशेषतः अशा परिस्थितीत जिथे तिने गर्भधारणा सुरु ठेवण्यास स्पष्टपणे अनिच्छा व्यक्त केली आहे.'

उच्च न्यायालयाने अल्पवयीन बलात्कार पीडितेच्या आईची याचिका फेटाळून लावली आणि त्यामुळे तिने उच्च न्यायालयाच्या आदेशाला आव्हान देत सर्वोच्च न्यायालयत धाव घेतली होती.

पाकिस्तान बॉम्बस्फोटाने हादरले

प्राथमिकीत एकत्र जमल्याने त्याच्याभोवती कडेकडे बंदोबस्त ठेवण्यात आला होता. या स्फोटानंतर मशिदीचे मुख्य प्रवेशद्वार आणि शेजारील इमारतीच्या खिडक्यांनाही तडे गेले. रस्त्यावर अक्षरशः रक्ताचा सडा पडला होता, जखमी लोक हे विव्हाळ होते, असे समाजमाध्यमांमध्ये व्हायरल झालेल्या व्हिडिओतून दिसून येते. या स्फोटानंतर पोलिस महानिरीक्षकांनी तातडीने शहरातील बंदोबस्तामध्ये वाढ करत संचारबंदी लागू केली. बचाव पथके घटनास्थळी रवाना झाल्याचे 'दि टाइम्स ऑफ इस्लामाबाद'ने प्रसिद्ध केलेल्या वृत्तामध्ये म्हटले आहे. या स्फोटातील जखमींना उपचारासाठी 'पाकिस्तान इन्स्टिट्यूट ऑफ मेडिकल सायन्सेस' (पीआयएमएस) आणि 'पोलिक्लिनिक हॉस्पिटल'मध्ये दाखल करण्यात आले आहे. तत्पूर्वी ११ नोव्हेंबर २०२५ रोजी



इस्लामाबाद : पाकिस्तानमधील इस्लामाबाद येथे शुक्रवारी नमाज सुरु असताना एका मशिदीत आत्मघाती बॉम्बस्फोट झाला. त्यानंतर स्थानिकांनी घटनास्थळी पाहणी केली. स्फोटात ३० जणांचा मृत्यू झाला असून अनेक जण जखमी झाले आहेत.

इस्लामाबादतील सत्र न्यायालयाच्या बाहेरदेखील अशाच प्रकारचा भीषण स्फोट झाला होता, त्या स्फोटात १२ जणांचा मृत्यू झाला होता, तर ३०पेक्षाही अधिक लोक हे जखमी झाले होते. पाकिस्तानचे पंतप्रधान शाहबाज शरीफ यांनी ताच्या बॉम्बस्फोटाचा कठोर शब्दांत निषेध केला आहे. दरम्यान, या स्फोटाची अद्याप कोणत्याही दहशतवादी संघटनेने जबाबदारी घेतलेली नाही.
