Details of the violation(s)/ contravention(s) committed or alleged to be committed	The Company has received an initial demand order under the Income tax Act amounting to INR 31,77,40,209 for the aforementioned assessment years. Pursuant to opting settlement under the Scheme resulted in reduced tax liability amounting to INR 6,173 for the aforementioned assessment years which was paid by the Company to the Authority while filing Form-3. There will be no further interest and penalties as result of settlement under the Scheme, with this, all the pending demands received till date for the aforementioned assessment years are settled.
