A fake message is being circulated in the social media including what's app regarding Company's Ammonia Plant which they claim to be currently under shut down and may remain so for another 18 months, similarly for the Melamine Plants that they are facing frequent shut downs. While for the Caprolactam Plants, it is said that the same is not running at the full capacity. Investors are advised to be cautious and beware of such unscrupulous elements circulating fake messages mischievously.

In this regard, Company categorically deny all these baseless allegations and declare them to fake and also would like to state that Ammonia Plant is running perfectly and producing the 11000 MTs per day to meet up the requirements of various other integrated plants of GSFC.

Similarly, in case of Melamine and Caprolactam, please note that these plants are running at full capacity. Melamine Plants are running at 100% while the Caprolactam Plants at 123%, not only this, all the other major plants of the company are also performing at high capacities viz. Urea (107%), APS (235%), AS (256%), MEK Oxime (143%), Nylon-6 Plants (125%), Argon (111%), Phosphoric Acid (109%), HX Plants (133%) and Sulphuric Acid (106%).

We, therefore, would like to advise investors not to get swayed by this false and baseless information being circulated solely with intention to damage the reputation of the genuinely performing company.
