बेसा-पिपळा रस्त्याच्या अर्धवट बांधकामामुळे नागरिक संतप्त

निवडणुकीवर बहिष्काराचा इशारा

लोकसत्ता खास प्रतिनिधी

नागपूर : नवे नागपूर म्हणून उदयाला असलेल्या बेसा परिसरात पिपळा रस्त्यावर सुरू असलेल्या सिमेंटच्या संथ कामामुळे आधीच वर्षभरापासून नागरिक संतप्त आहेत. रस्त्यावरून जाताना अंधारामुळे खड्डा न दिसल्याने मागील आठवड्यात ७२ वर्षीय रंगराव पाटील यांचा मृत्यू झाला. त्यामुळे 'मृत्यूचा सापळा' असे फलक हातात घेऊन रस्त्यावर उतरलेल्या बेसा-पिपळा ग्रामस्थांनी आधी रस्त्याचे काम पूर्ण करा, मगच मत माग्याला या आणि त्यानंतर आम्ही मतदान करायचे की नाही, हे ठरवू, असा पवित्रा घेतला आहे. आक्रमक होत टोकाची भूमिका घेतलेल्या रंगरोड नागरिकांनी सार्वजनिक बांधकाम विभागाच्या विरोधात घोषणा देत परिसर दिवाणपून सोडला.

बेसा-पिपळा मार्गावर अनेक महिन्यांपासून सुरू असलेल्या रस्त्याच्या कामामुळे टिकटिकाणी खड्डे, चढ-उतार तयार झाले. त्यामुळे हा रस्ता मृत्यूचा सापळा झाला आहे, असे आंदोलकांचे म्हणणे होते. आंदोलनात मोठ्या संख्येने ज्येष्ठ महिला व पुरुष सहभागी झाले. 'रस्त्याचे काम तत्काळ न झाल्यास येत्या काळात निवडणुकांवर बहिष्कार घालून आम्हीच रस्ता पूर्ण

या रस्त्याच्या स्थितीवर संतप्त नागरिक रस्ता रोकोच्या तयारी होते. मात्र, स्थानिक स्वराज्य संस्था निवडणुकांच्या आचारसंहितेचे कारण देत हुडकेधर पोलिसांनी याची परवानगी नाकारली. अखेर नागरिकांनी रस्ता रोको न करता शांततेत आंदोलन केले.

Approval of our Resolution Plan is challenged by unsuccessful applicants in the hon'ble Supreme Court, following rejection of their appeal in the NCLAT. Further, pursuant to the RP, the Group amalgamated SKS with itself w.e.f. Appointed Date of September 1, 2024. Results of current year includes the numbers of SKS for the full period, hence not comparable with the second quarter / half year of the previous periods.
