**Sub: Scrutinizer's Report on Postal Ballot voting by way of electronic means in respect of passing of the Resolution set-out in the Notice dated January 14, 2026 through Postal Ballot.**

I, CS Tushar Pahade, Proprietor at M/s T.S. Pahade & Associates, Company Secretaries had been appointed as the Scrutinizer by the Board of Directors of the **Solar Industries India Limited ("the Company")** for the purpose of scrutinizing the Postal Ballot voting conducted by way of electronic means ("**remote e-voting**") in a fair and transparent manner on the resolution contained in the Postal Ballot Notice dated **January 14, 2026 ("Notice")** issued pursuant to Section 110 read with Section 108 and other applicable provisions, if any, of the Companies Act, 2013 ("**Act**"), Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014 ("**Rules**"), as amended from time to time, along with the General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No.22/2020 dated June 15, 2020, General Circular No. 33/2020 dated September 28, 2020, General Circular No. 39/2020 dated December 31, 2020, General Circular No. 10/2021 dated June 23, 2021, General Circular No. 20/2021 dated December 8, 2021, General Circular No. 03/2022 dated May 5, 2022 and with other relevant circulars, including General Circular No. 09/2023 dated September 25, 2023, Circular No. 9/2024 dated September 19, 2024 and latest being Circular No. 03/2025 dated September 22, 2025 issued by the Ministry of Corporate Affairs (Collectively referred to as "**MCA Circulars**"), Secretarial Standard on General Meetings ("**SS-2**") issued by the Institute of Company Secretaries of India, Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("**SEBI Listing Regulations**"),



and other applicable laws and regulations (including any statutory modification or re-enactment thereof for the time being in force) that the following Special business set out below is proposed to be passed by the Members of Solar Industries India Limited, through Postal Ballot by electronic means (**remote e-voting**) only.

I am pleased to present the Report on the Postal Ballot conducted by **Solar Industries India Limited** seeking consent of its Members through Special Resolution as contained in the Notice of Postal Ballot dated **January 14, 2026**.

1. In terms of provisions of Section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014, I was appointed as the Scrutinizer by the Company to conduct the Postal Ballot as contained in the Notice dated **January 14, 2026**.

In terms of Sections 110 and 108 of the Companies Act, 2013, and all other applicable provisions, if any, of the Act read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, and extant Circulars issued by Ministry of Corporate Affairs in this regard, approval by way of **Special Resolution** were sought for:

**Resolution 1:** Appointment of **Shri Ramesh Madhavrao Bhujang (DIN: 00194189)** as an Independent Director of the Company.

## 2. Notice of Postal Ballot:

- 2.1. The Company had hosted the Notice of Postal ballot on its website on **January 23, 2026**.
- 2.2. Intimation regarding dispatch of Postal Ballot Notice was published on **January 24, 2026** in **Loksatta** (Nagpur Edition) and **Business Standard** (All India Edition).
- 2.3. The Company has informed that, Notice of Postal Ballot is sent to the Members of the Company whose names appear on the Register of Members/List of Beneficial Owners as on **Friday, January 16, 2026** ("**the cut-off date**") and who have registered their e-mail addresses with the Company or with the depository(ies)/depository participants.
- 2.4. The Company has completed sending of Postal Ballot Notice through E-Mail on **January 23, 2026** to **1,15,072** Members who had registered their email-ids with the Company or with the depository(ies) / depository participants.



- 2.5. The Notice has also been uploaded on the Website of the Company at [www.solargroup.com](http://www.solargroup.com) The Notice can also be accessed from the website of the Stock Exchanges i.e. BSE Limited (“BSE”) and National Stock Exchange of India Limited (“NSE”) at [www.bseindia.com](http://www.bseindia.com) and [www.nseindia.com](http://www.nseindia.com) respectively and the Notice is also available on the website of National Securities Depository Limited (“NSDL”) (agency for providing the remote e-voting Facility) i.e. [www.evoting.nsdl.com](http://www.evoting.nsdl.com).
3. In terms of the aforesaid Notice, Members were required to convey their assent or dissent, only through remote e-voting system, on e-voting platform provided by NSDL from **Saturday, January 24, 2026 at 09:00 A.M. (IST) to Monday, February 23, 2026 at 5:00 P.M. (IST)**.
  4. **956 Members** had casted their votes on the e-voting platform till **5:00 p.m. (IST) on Monday, February 23, 2026**.
  5. Members' demographic details and their voting rights were provided by NSDL.
  6. The Management of the Company is responsible to ensure compliance with the requirements of the Act and Rules relating to the remote e-voting on resolution contained in the Postal Ballot Notice.
  7. My responsibility as scrutinizer for the remote e-voting is restricted to making a Scrutinizer's Report of the votes cast for assent or dissent of the resolutions.
  8. After the scrutiny of the remote e-voting results, I report that the Special Resolution as contained in the Notice of Postal Ballot dated **January 14, 2026** has failed to get the requisite majority.

Further, pursuant to sub-regulation 2A of Regulation 25 of SEBI Listing Regulations (Sixth amendment) 2022, where a special resolution for the appointment of an independent director fails to get the requisite majority of votes but the votes cast in favour of the resolution exceed the votes cast against the resolution and the votes cast by the public shareholders in favour of the resolution exceed the votes cast against the resolution, then the appointment of such an independent director shall be deemed to have been made under sub-regulation (2A).

In light of the above amendment, **Shri Ramesh Madhavrao Bhujang (DIN: 00194189)** shall be deemed to be appointed as an Independent Director of the Company under Regulation 25(2A) of SEBI Listing Regulations.



9. The electronic data and all other relevant records relating to e-voting were handed over to CS Khushboo Pasari, Company Secretary & Compliance officer of Solar Industries India Limited.
