Subject: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform that the Company has received a communication from GAIL (India) Limited stating that due to the ongoing conflict in the Middle East and its impact on global energy markets and as per the revised supply regulations issued pursuant to the Ministry of Petroleum & Natural Gas notification dated 9th March 2026, gas supplies to industrial consumers shall be maintained at 80% of the past six months' average gas consumption and any overdrawl shall be invoiced as per the applicable contractual terms and conditions, with effect from 12th March 2026 (06:00 hours).

In view of the above, the plant of the Company located at Kassar, Bahadurgarh, Haryana ("Plant") shall receive restricted gas supply.

This may have a partial impact on the Company's production activities at the Plant. The Company is actively evaluating the situation and taking necessary measures to minimize the impact. Considering the Company's existing inventory levels, supplies are continuing in the normal course of business.

The Company will continue to monitor the situation and will inform the stock exchanges of any material developments, if any.
