Sub: Disclosure under regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 – order dated 9th February, 2026 passed by the Hon’ble Supreme Court of India in the matter of National Highways Authority of India Vs Vadodara Mumbai Expressway PKG-08 Private Limited (SPV), Incorporated by Roadway Solutions India Infra Limited, the Promoter & Holding Company of Soma Textiles and Industries Ltd.

Dear sir/ma’am,

Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform you that the Hon’ble Supreme Court of India, vide its order dated **9th February 2026**, has passed directions in an arbitration-related matter involving Roadways Solutions India Infra Limited (“Roadways”), which is the Promoter and Holding Company of Soma Textiles & Industries Ltd.

The matter arises out of a Concession Agreement dated **22nd June, 2021** relating to the Vadodara–Mumbai Expressway Project (Packages VIII & IX). An Arbitral Award dated **1st August, 2025** had been passed in connection with the said project. The award was challenged under **Section 34 of the Arbitration and Conciliation Act, 1996** before the Hon’ble Delhi High Court.

The Hon’ble Supreme Court, while disposing of the Special Leave Petitions filed in the matter, has directed the petitioner, **National Highways Authority of India**, to deposit 50% of the total awarded amount (aggregate award of Rs. 1,019,02,63,440/- plus interest aggregating to Rs. 1,197,72,60,596/- as on 09.02.2026) before the Registry of the Hon’ble Delhi High Court within a period of eight weeks from the date of the Order, i.e., 09.02.2026, under Section 34 of the Arbitration and Conciliation Act, 1996. The respondent, Roadways Solutions India Infra Limited has been permitted to withdraw the said amount upon furnishing an irrevocable and unconditional bank guarantee. The remaining 50% of the awarded amount will be received only after final hearing before the Hon’ble Delhi High Court on 14.07.2026.

Soma Textiles & Industries Ltd. is not a party to the said proceedings. Based on the information currently available, the aforesaid order does not have any direct material impact on financial or operational activities of Soma Textiles & Industries Ltd.

The Company received information regarding the aforesaid order on **14th February, 2026** and is accordingly intimating the Stock Exchanges within the prescribed timeline in compliance with Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

1.	Name of the authority	Hon'ble Supreme Court of India

Nature and details of the action(s) taken, initiated or order(s) passed	The Hon'ble Supreme Court of India, vide Order dated 9 th February, 2026 in Special Leave Petition (C) Nos. 622–623 of 2026 and 1567–1568 of 2026 (National Highways Authority of India vs. Vadodara Mumbai Expressway Pkg-08 Private Limited), modified the order passed by the Hon'ble Delhi High Court in the proceedings under Section 34 of the Arbitration and Conciliation Act, 1996. The Hon'ble Supreme Court directed the petitioner, National Highways Authority of India , to deposit 50% of the total awarded amount (aggregate award of Rs. 1,019,02,63,440/- plus interest aggregating to Rs. 1,197,72,60,596/- as on 09.02.2026) before the Registry of the Hon'ble Delhi High Court within a period of eight weeks from the date of the Order, i.e., 09.02.2026. Upon such deposit, the respondent, Roadways Solutions India Infra Limited shall be permitted to withdraw the said amount subject to furnishing an irrevocable and unconditional bank guarantee to the satisfaction of the Registrar General of the Hon'ble Delhi High Court.
3.	Date of receipt of direction or order, including any ad-interim or interim orders, or any other communication from the authority	The Order was passed on 9 th February, 2026 by the Hon'ble Supreme Court of India. The Company received intimation of the said Order on 14 th February, 2026. The Order is interim in nature. Pursuant thereto, Roadways / the concerned entity has received 50% of the total awarded amount (aggregate award of Rs. 1,019,02,63,440/- plus interest aggregating to Rs. 1,197,72,60,596/- from NHAI as on 09.02.2026). The final hearing of the petition under Section 34 of the Arbitration and Conciliation Act, 1996 is scheduled for 14.07.2026 before the Hon'ble Delhi High Court, which date has already been fixed. Accordingly, respondent Roadways Solutions India Infra Limited ("Roadways") shall retain the remaining 50% of the awarded amount subject to the outcome of the final hearing before the Hon'ble Delhi High Court on 14.07.2026.
4.	Details of the violation(s)/ contravention(s) committed or alleged to be committed	The matter pertains to disputes arising out of a Concession Agreement dated on 22 nd June, 2021 relating to the Vadodara–Mumbai Expressway Project (Packages VIII & IX). The dispute concerns termination and financial closure obligations under the Concession Agreement and subsequent arbitral award. There is no violation or contravention alleged against Soma Textiles & Industries Ltd. The proceedings involve the Holding Company's SPV and National Highways Authority of India .
