I Ira Baxi, Practicing Company Secretary, was appointed as a Scrutinizer by the Board of Directors of the Company, for the Extra-Ordinary General Meeting of the members of the "SOMI CONVEYOR BELTINGS LIMITED" to be held on Monday, 8th January, 2024 at 11.30.A.M. at its registered office at 4F-15, "Oliver House", New Power House Road, Jodhpur for the purpose of scrutinizing the E-Voting process pursuant to the provision of Section 108 of the Companies Act, 2013 read with Rule 20 of Companies (Management and Administration) Rules, 2014 as amended and Voting through Poll pursuant to the provision of Section 109 of the Companies Act, 2013 read with Rule 21 of Companies (Management and Administration) Rules, 2014 as amended in a fair and transparent manner in respect of the resolution referred to in this report.

I hereby submit my report as under:

1. The resolution was transacted through the process of remote e-voting and Voting through Poll at the EOGM. For the purpose of e-voting the company has engaged CDSL for its services

2. The E-voting period remained open from Friday, 05.01.2024 (9.00 a.m.) up to Sunday, 07.01.2024 (05.00 p.m.).
3. The Shareholders holding shares as on the “cut off” date, i.e. 1st January, 2024 were entitled to vote on the proposed resolution as mentioned in the Notice of the Extra-Ordinary General Meeting of Somi Conveyor Beltings Limited (Item Number 1 of the Notice of the Extra-Ordinary General Meeting of Somi Conveyor Beltings Limited).
4. For the members who did not cast their vote through remote e-voting facility, the Company has provided the facility of voting through Poll at the Venue of Meeting.
