India is central to key supply chains, says Canadian PM

INDIA IS THE fifth largest economy in the world and it is central to a number of critical global supply chains, Canadian Prime Minister Mark Carney has said, arguing that the leadership of the country must be part of discussions at the upcoming G7 summit.

Carney's comments came after some of his political opponents in Canada criticised him for inviting Prime Minister Narendra Modi to the G7 summit in view of a probe into allegations of Indian links to the killing of a Khalistani separatist in 2023.

PM Modi accepted Carney's invitation to attend the G7 summit during a phone conversation on Friday.

Canada is hosting the G7 summit in the Alberta province from June 15 to 17 in its capacity as the current chair of the grouping.

To a specific question on the case of killing of pro-Khalistan separatist Hardeep Singh Nijjar in 2023, Carney told reporters that it is not appropriate for him to comment as the legal process in the case is underway.

The Canadian PM said the G7 summit will deliberate on a range of key issues including energy security, digital future, critical minerals and on partnerships in building infrastructure in the emerging and developing world.

Carney suggested that he extended the invitation to

Modi after talking to other G7 member countries. "There are certain countries that should be at the table for those discussions," he said.

"India is the fifth largest economy in the world; effectively the most populous country in the world. (It is) central to a number of those supply chains, so it makes sense," he said.

Without elaborating, Carney noted that India and Canada have agreed to continue law enforcement dialogue. "Bilaterally, we have now agreed importantly to continue law enforcement dialogue. There has been some progress on that... recognises issues of accountability," he said.

Canada's NDP party

slammed Carney for extending the invitation to Modi. "This decision is profoundly troubling," it said.

India-Canada relations hit rock bottom following then PM Justin Trudeau's allegations in 2023 of a potential Indian link to the killing of Nijjar. In October last year, India recalled its high commissioner and five other diplomats after Ottawa attempted to link them to the Nijjar case. India also expelled an equal number of Canadian diplomats.

However, Liberal Party leader Carney's victory in the parliamentary election in April triggered hopes for reset of the relationship. In the last few months, the security officials of India and Canada resumed contacts and both sides were looking at the possibility of appointing new high commissioners.

China approves some exports of rare earths ahead of US talks

Has not specified countries or the industries covered

BEIJING ON SATURDAY said it has granted approval to some applications for the export of rare earths, a move that could ease tensions before trade negotiations between the US and China next week.

The Chinese commerce ministry confirmed the approval of the applications without specifying which countries or industries were covered, even as it noted growing demand for the minerals in robotics and electric vehicles. The ministry will continue to review and approve compliant export applications.

Delegations from Beijing and Washington are scheduled to meet in the UK to conduct trade negotiations on Monday.

China also said it is willing to accelerate the examination and approval of rare earth exports to European Union firms and will also deliver a verdict on its trade investigation of EU brandy imports by July 5.

Most recently, China's decision in April to suspend exports

of a wide range of rare earths and related magnets has upended the supply chains central to automakers, aerospace manufacturers, semiconductor companies and military contractors around the world.

Commerce minister Wang during the meeting "expressed the hope that the EU will meet us halfway and take effective measures to facilitate, safeguard and promote compliant trade in high-tech products to China."

Meanwhile, President Donald Trump on Friday said his Chinese counterpart Xi Jinping had agreed to restart the flow of rare-earth materials, as negotiators from the two nations

reference to the trade deal," Trump said Friday on social media. "The meeting should go very well."

Earlier talks between the two countries in Switzerland in May resulted in a tariff truce between Beijing and Washington that set the stage for further discussions on trade. But negotiations between the rivals stalled after the Geneva meeting, with both sides accusing the other of violating the agreement that brought down duties from massive highs.

The US expressed concerns over the lack of rare-earth magnets essential for American electric vehicles and defense systems, while China bristled at fresh US restrictions on artificial intelligence chips from Huawei Technologies, as well as other advanced technologies and crackdowns on foreign students in the US.

Asked Friday if Xi had agreed to restart the flow of rare-earth minerals and magnets, Trump told reporters on Air Force One: "Yes he did." China also approved temporary export licenses to critical mineral suppliers to major US automakers, Reuters reported earlier.

But questions remain about what Trump conceded to Xi in their call, which the US president had eagerly sought.

With India in fight against terrorism: US official

THE US STANDS strong with India in the fight against terrorism, US deputy secretary of state Christopher Landau told Congress MP Shashi Tharoor-led all-party delegation.

The Indian delegation met Landau as it wrapped up the US leg of its multi-nation tour, briefing key interlocutors about Operation Sindoor. "The all-party parliamentary delegation led by Dr @ShashiTharoor had a warm and candid conversation with US deputy secretary of state Landau. The Indian delegation briefed him on the atrocities of the Pahalgam terror attack and Operation Sindoor," the Indian Embassy said on X.

Landau, in a post on X, said it was a "GREAT" meeting with the Indian parliamentary representatives.

Philippines offers Indians visa-free travel

THE PHILIPPINES SAID that Indian nationals will be allowed to enter the country without a visa for tourism purposes beginning June 8. The visa-free arrangement is aimed at boosting tourism arrivals from India, which rose 12% in 2024 to nearly 80,000.

Indian nationals can enter the Philippines without a visa for up to 14 days. Those holding valid visas or residence permits from the US, Australia, Canada, Schengen countries, Singapore, or the UK can stay visa-free for up to 30 days.

Hope Musk returns to the fold: Vance

VICE PRESIDENT JD Vance said Elon Musk is making a "huge mistake" in going after Donald Trump and expressed hopes the billionaire will come back into the fold following the public feud that unfolded.

"I'm always going to be loyal to the president and I hope that eventually Elon kind of comes back into the fold," Vance said in an interview on the podcast *This Past Weekend* / *Theo Von* on Saturday. "Maybe that's not possible now because he's gone so nuclear, but I hope it is!"

Musk helped elect Trump and Vance in 2024 and assumed a role heading the department of government efficiency. Trump and Musk's political alliance imploded on Thursday after Musk criticised the tax and spending policy bill backed by the president. The two men traded jabs that grew

personal on social media.

While Vance posted on X, saying that the hewas "proud to stand beside Trump" and praising him as having "done more than anyone in my lifetime to earn the trust of the movement he leads," the interview marked his first direct comments on Musk since the spat erupted.

India is central to key supply chains, says Canadian PM

INDIA IS THE fifth largest economy in the world and it is central to a number of critical global supply chains, Canadian Prime Minister Mark Carney has said, arguing that the leadership of the country must be part of discussions at the upcoming G7 summit.

Carney's comments came after some of his political opponents in Canada criticised him for inviting Prime Minister Narendra Modi to the G7 summit in view of a probe into allegations of Indian links to the killing of a Khalistani separatist in 2023.

PM Modi accepted Carney's invitation to attend the G7 summit during a phone conversation on Friday.

Canada is hosting the G7 summit in the Alberta province from June 15 to 17 in its capacity as the current chair of the grouping.

To a specific question on the case of killing of pro-Khalistan separatist Hardeep Singh Nijjar in 2023, Carney told reporters that it is not appropriate for him to comment as the legal process in the case is underway.

The Canadian PM said the G7 summit will deliberate on a range of key issues including energy security, digital future, critical minerals and on partnerships in building infrastructure in the emerging and developing world.

Carney suggested that he extended the invitation to

Modi after talking to other G7 member countries. "There are certain countries that should be at the table for those discussions," he said.

"India is the fifth largest economy in the world; effectively the most populous country in the world. (It is) central to a number of those supply chains, so it makes sense," he said.

Without elaborating, Carney noted that India and Canada have agreed to continue law enforcement dialogue. "Bilaterally, we have now agreed importantly to continue law enforcement dialogue. There has been some progress on that... recognises issues of accountability," he said.

Canada's NDP party

slammed Carney for extending the invitation to Modi. "This decision is profoundly troubling," it said.

India-Canada relations hit rock bottom following then PM Justin Trudeau's allegations in 2023 of a potential Indian link to the killing of Nijjar. In October last year, India recalled its high commissioner and five other diplomats after Ottawa attempted to link them to the Nijjar case. India also expelled an equal number of Canadian diplomats.

However, Liberal Party leader Carney's victory in the parliamentary election in April triggered hopes for reset of the relationship. In the last few months, the security officials of India and Canada resumed contacts and both sides were looking at the possibility of appointing new high commissioners.

China approves some exports of rare earths ahead of US talks

Has not specified countries or the industries covered

BEIJING ON SATURDAY said it has granted approval to some applications for the export of rare earths, a move that could ease tensions before trade negotiations between the US and China next week.

The Chinese commerce ministry confirmed the approval of the applications without specifying which countries or industries were covered, even as it noted growing demand for the minerals in robotics and electric vehicles. The ministry will continue to review and approve compliant export applications.

Delegations from Beijing and Washington are scheduled to meet in the UK to conduct trade negotiations on Monday.

China also said it is willing to accelerate the examination and approval of rare earth exports to European Union firms and will also deliver a verdict on its trade investigation of EU brandy imports by July 5.

Most recently, China's decision in April to suspend exports

of a wide range of rare earths and related magnets has upended the supply chains central to automakers, aerospace manufacturers, semiconductor companies and military contractors around the world.

Commerce minister Wang during the meeting "expressed the hope that the EU will meet us halfway and take effective measures to facilitate, safeguard and promote compliant trade in high-tech products to China."

Meanwhile, President Donald Trump on Friday said his Chinese counterpart Xi Jinping had agreed to restart the flow of rare-earth materials, as negotiators from the two nations

prepare to resume trade talks on June 9 in London.

The developments come as the world's two largest economies look to resolve a simmering dispute over tariffs and technology that has unnerved markets. Trump and Xi held a 90-minute call on Thursday that saw the two agree to defuse growing tensions spurred by concerns over the flow of critical minerals needed by American firms.

US treasury secretary Scott Bessent, commerce secretary Howard Lutnick and US trade representative Jamieson Greer are set to meet Monday "with representatives of China, with

reference to the trade deal," Trump said Friday on social media. "The meeting should go very well."

Earlier talks between the two countries in Switzerland in May resulted in a tariff truce between Beijing and Washington that set the stage for further discussions on trade. But negotiations between the rivals stalled after the Geneva meeting, with both sides accusing the other of violating the agreement that brought down duties from massive highs.

The US expressed concerns over the lack of rare-earth magnets essential for American electric vehicles and defense systems, while China bristled at fresh US restrictions on artificial intelligence chips from Huawei Technologies, as well as other advanced technologies and crackdowns on foreign students in the US.

Asked Friday if Xi had agreed to restart the flow of rare-earth minerals and magnets, Trump told reporters on Air Force One: "Yes he did." China also approved temporary export licenses to critical mineral suppliers to major US automakers, Reuters reported earlier.

But questions remain about what Trump conceded to Xi in their call, which the US president had eagerly sought.

With India in fight against terrorism: US official

THE US STANDS strong with India in the fight against terrorism, US deputy secretary of state Christopher Landau told Congress MP Shashi Tharoor-led all-party delegation.

The Indian delegation met Landau as it wrapped up the US leg of its multi-nation tour, briefing key interlocutors about Operation Sindoor. "The all-party parliamentary delegation led by Dr @ShashiTharoor had a warm and candid conversation with US deputy secretary of state Landau. The Indian delegation briefed him on the atrocities of the Pahalgam terror attack and Operation Sindoor," the Indian Embassy said on X.

Landau, in a post on X, said it was a "GREAT" meeting with the Indian parliamentary representatives.

Philippines offers Indians visa-free travel

THE PHILIPPINES SAID that Indian nationals will be allowed to enter the country without a visa for tourism purposes beginning June 8. The visa-free arrangement is aimed at boosting tourism arrivals from India, which rose 12% in 2024 to nearly 80,000.

Indian nationals can enter the Philippines without a visa for up to 14 days. Those holding valid visas or residence permits from the US, Australia, Canada, Schengen countries, Singapore, or the UK can stay visa-free for up to 30 days.

"I'm always going to be loyal to the president and I hope that eventually Elon kind of comes back into the fold," Vance said in an interview on the podcast *This Past Weekend* / *Theo Von* on Saturday. "Maybe that's not possible now because he's gone so nuclear, but I hope it is."

Musk helped elect Trump and Vance in 2024 and assumed a role heading the department of government efficiency. Trump and Musk's political alliance imploded on Thursday after Musk criticised the tax and spending policy bill backed by the president. The two men traded jabs that grew

personal on social media.

While Vance posted on X, saying that the hewas "proud to stand beside Trump" and praising him as having "done more than anyone in my lifetime to earn the trust of the movement he leads," the interview marked his first direct comments on Musk since the spat erupted.
