## Not living in alien world: HC to officials over pollution

**Mumbai:** The Bombay high court on Friday slammed civic authorities for their "belligerent disregard" of its orders to mitigate air pollution, noting they too are breathing the same impure air and not living in some "alien world" as it warned of halting salaries of top officials.

A bench of Chief Justice Shree Chandrashekar and Justice Suman Shyam warned to stop the salaries of the civic commissioners of both Mumbai and Navi Mumbai for not complying with court orders and failing to take measures towards the deteriorating air quality index (AQI).

"Take this as a warning. We will stop the salaries of the (civic) commissioners (for non-compliance of court orders)," it added, while posting the matter for further hearing on Jan 27.

In 2023, the court had taken suo motu (on its own) cognisance of increasing air pollution and passed a slew of directions to civic bodies and other authorities to take steps.

BMC counsel S U Kamdar told the court that the civic body has issued stop work notices to several construction sites and that of the 600 sites where air quality monitors were required, the devices have been installed at around 400 of them.

The court sought a detailed report of data on air quality monitoring and directed the BMC to submit daily sensor data for three months prior to November 2025. **PTI**

# Sena minister Gogawale's son surrenders in poll clash case

## Move After HC Raps Govt For No Action

**Mumbai:** A day after the Bombay high court came down heavily on the Maharashtra govt for failing to take action in the Mahad poll violence, Shiv Sena minister Bharat Gogawale's son Vikas Gogawale surrendered before the police in the case.

The state govt on Friday told the court that Vikas Gogawale had turned himself in at the Mahad police station in connection with the clash that broke out during the municipal council elections in Raigad district on Dec 2.

# Cong mocks Maha's ₹30L-cr Davos MoU claim

**New Delhi:** Amid Maharashtra govt's claim that it signed MoUs worth Rs 30 lakh crore at the World Economic Forum in Davos, Congress on Friday mocked that the Davos investment claim stood at Rs 3 lakh crore in 2024 and Rs 15 lakh crore in 2025, but did not result in any increase in production or jobs in the state.

Sathe on Friday submitted to a single bench of Justice Madhav Jamdar that all the accused in the case, including Vikas Gogawale and his cousin Mahesh Gogawale and six others surrendered before the Mahad police in the morning. The court accepted the statement.

Clashes broke out between supporters of Eknath Shinde-led Shiv Sena and the NCP, headed by Ajit Pawar, during the civic elections at Mahad in Raigad district. Both Shinde and Pawar are deputy chief ministers in the BJP-led govt.

The two sides lodged complaints against each other, and cross-FIRs were registered. The court was hearing the pre-arrest bail plea of Shreeyansh Jagtap.

In the previous hearing, the court noted that the offence was serious and hence, it was not inclined to grant anticipatory bail to Shreeyansh Jagtap. Based on this, Shreeyansh Jagtap on Friday withdrew his application, which the court allowed. Justice Jamdar, after the hearing, quipped that the issue involved the two deputy chief ministers of Maharashtra.

Vikas Gogawale and his cousin Mahesh had also sought pre-arrest bail pleas, but they were not granted any relief. Shreeyansh Jagtap was granted interim protection from arrest in Dec. Both Vikas and Mahesh Gogawale had filed applications opposing Jagtap's pre-arrest bail plea. **PTI**

# HC grants bail to 2 activists in Elgar case; only 1 left in jail

**Mumbai:** The Bombay high court on Friday granted bail to activists Sagar Gorkhe and Ramesh Gaichor, accused in the Elgar Parishad case, on the grounds of parity, noting that other accused have been granted similar relief.

Gorkhe and Gaichor were arrested in Sept 2020 and are presently lodged at the Talaja prison. The duo is accused of being active members of the banned CPI (Maoist) group. All except one accused, Surendra Gadling, have now been granted bail in the case.

A bench, headed by Justice A S Gadkari, noted that several other accused in the case have been granted bail on the grounds of long incarceration and the possibility of the trial in the case not commencing in the near future. "Hence on the ground of parity, the two appellants (Gorkhe and Gaichor) too deserve to be released on bail," it said.

The duo has been directed to furnish a bail bond of Rs 1 lakh each and to attend the National Investigation Agency's office once a month.

At least 16 people, including prominent lawyers, activists, and academics, were booked in connection with allegedly provocative speeches that were delivered at the Elgar Parishad conclave

held in Pune on Dec 31, 2017. According to the police, the speeches triggered violence at Koregaon-Bhima, on the outskirts of Pune city, the next day.

The Pune police, which initially probed the case, claimed that Maoists had backed the conclave. The NIA later took over the probe into the case.

Father Stan Swamy, an 84-year-old priest and tribal rights activist, died while in custody in July 2021, awaiting trial.

The other accused in the case include Varavara Rao, Sudha Bharadwaj, Anand Telumbde, Vernon Gonsalves, Arun Ferreira, Shoma Sen, Gautam Navlakha, Sudhir Dhawale, Rona Wilson, Jyoti Jagtao and Mahesh Raut. **PTI**

# Hearing of 2015 Akhlaq case on Feb 5 as judge goes on leave

**Noida:** A court in Gautam Buddha Nagar on Friday deferred the recording of statements of family members of Mohammad Akhlaq in the 2015 lynching case and fixed Feb 5 as the next date of hearing as the additional district judge of the fast-track court was on leave.

Advocate Yusuf Saifi, who represents Akhlaq's family, said statements, including that of Akhlaq's wife Ikraman, were scheduled to be recorded on Friday but could not take place due to the judge's absence.

On Thursday, the district judge's court had rejected a transfer plea filed by the accused and ordered that the case be heard by the fast-track court.

Earlier, on Dec 23, the court had dismissed the Uttar Pradesh govt's application seeking withdrawal of the case against the accused and directed that it be categorised as "most important" and heard on a day-to-day basis. **PTI**

# Man gets 20 yrs' imprisonment for raping minor

**Thane:** A court in Maharashtra's Thane district has sentenced a man to 20 years of rigorous imprisonment for repeatedly raping a 17-year-old girl and impregnating her.

A special Pocco court judge, Ruby U Malvankar, on Thursday convicted Gaurang Girish Kanthariya (23) of charges under section 376(2)(n) (committing rape repeatedly on the same woman) of the IPC and relevant provision of Pocco Act.

According to the prosecution, Kanthariya, a resident of Bhayandar East, had befriended the survivor in 2021 with a promise of marriage and raped her on multiple occasions. A case was registered against him on Jan 30, 2022.

The repeated assaults led to pregnancy, and the girl subsequently delivered a baby boy on Aug 15, 2023. **PTI**
