

# महिला की हत्या मामले में पति समेत तीन गिरफ्तार

जम्मु, 11 सितंबर (भाषा)।

जम्मु-कश्मीर के किश्तवाड़ में अपनी पत्नी की हत्या करने के आरोप में एक शख्स, उसके भाई और मां को गिरफ्तार किया गया है।

पुलिस के एक प्रवक्ता ने बताया कि तीनों ने सोची समझी साजिश के तहत महिला की गला घोट कर हत्या की थी, ताकि उसके पति की कसूर साबित हो सके। उन्होंने बताया कि 11 जुलाई को एक समिति हॉल में नीतू देवी फंदे से लटकी मिली थी, जिसके बाद पुलिस ने मामले की जांच शुरू की। उन्होंने बताया कि उसके ससुराल वालों ने उसके माता-पिता को बताए बिना उसका अंतिम संस्कार शुरू कर दिया था और मृतका के माता-पिता ने पुलिस में शिकायत दर्ज कराई।

प्रवक्ता ने बताया कि शुरू में मृतका के ससुराल वालों ने कहा कि उसने फांसी लगा कर आत्महत्या की थी, लेकिन पूछताछ के दौरान, जांच अधिकारी ने मामले में गड़बड़ी का पता लगाया और फिर इसे हत्या के मामले में बदल दिया गया। उन्होंने कहा कि मामले की संवेदनशीलता को ध्यान में रखते हुए किश्तवाड़ के वरिष्ठ पुलिस अधीक्षक शफकत हुसैन बट ने एक विशेष जांच दल (एसआईटी) का गठन किया, जिसने कड़ी मशक्कत और संश्लेषण से पूछताछ के बाद मामलों का खुलासा किया। प्रवक्ता ने कहा कि यह साबित हो गया है कि नीतू देवी की हत्या उसके पति लोकेश कुमार, देवर गोवाश लाल और सास देवकी देवी ने दुपट्टे से गला घोट कर की थी।

## महाराष्ट्र : दो कैदियों ने कारापाल और उनके सहकर्मी पर किया हमला

ठाणे, 11 सितंबर (भाषा)।

महाराष्ट्र के ठाणे जिले के कल्याण स्थित आधारवाड़ी जेल में दो विचाराधीन कैदियों ने एक कारापाल और उनके सहयोगी पर धारदार हथियारों से हमला किया। पुलिस ने शनिवार को यह जानकारी दी। उन्होंने बताया कि यह घटना इस सप्ताह की शुरुआत में हुई और इस संबंध में खड्कपाड़ा पुलिस थाने में दोनों कैदियों के खिलाफ मामला दर्ज किया गया। कैदियों की पहचान मोहम्मद अलताफ उर्फ मफताब खालिद शेख और अकित महेंद्र प्रसाद के रूप में हुई है।

पुलिस ने बताया कि पीड़ितों को इस घटना में चोट पहुंची है। पुलिस में शिकायत में कारापाल आनंद पंसारे ने कहा कि बुधवार को जब वह ड्यूटी पर थे तो उन्होंने विचाराधीन कैदी को एक ऐसी कोठरी से बाहर आते देखा, जहां उसे होने की अनुमति नहीं थी। वह जब अलताफ से इस बारे में पूछ ही रहे थे कि दूसरे कैदी ने ब्लेड से उन पर हमला कर उन्हें गंभीर रूप से घायल कर दिया। वहीं जेल में तैनात सिपाही भाउसाहेब गांजवे उन्हें बचाने आए तो दोनों ने उन पर भी ब्लेड और कटर से हमला कर दिया।
