# Israeli leaders support mass relocation of Palestinians from Gaza

TEL AVIV, AUG 16 /--/ President Donald Trump has said little about his idea of relocating many of the Gaza Strip's 2 million Palestinians to other countries since he stunned the world by announcing it in February.

But Israel's leaders have run with it, and Prime Minister Benjamin Netanyahu at one point listed it as a condition for ending the 22-month war sparked by Hamas' October 7, 2023, attack.

He and other Israeli officials present it as a humanitarian measure allowing Palestinians to flee war and hardship, and say it should be voluntary. Israel has been in talks with Af-

rican countries – many of which are themselves wracked by war and at risk of famine – about taking Palestinians in.

Palestinians say there would be nothing voluntary about leaving part of their homeland with no guarantee of return after an occupying power has rendered much of it uninhabitable. Rights groups and much of the international community say it would amount to forcible expulsion in violation of international law.

The issue is likely to take on greater urgency as Israel widens its military campaign to the last parts of Gaza that it hasn't taken over and largely flattened,

and as large numbers of Palestinians flee once again.

"This is our land, there is no other place for us to go," said Ismail Zaydah, whose family remained in Gaza City throughout the war, even after much of their neighbourhood and part of their home was destroyed. "We are not surrendering," he said. "We were born here, and here we die."

Defence Minister Israel Katz, in a February 6 post on X said, "I have instructed the (Israeli military) to prepare a plan that will allow any resident of Gaza who wishes to leave to do so, to any country willing to receive them.... The plan will include exit options via

land crossings, as well as special arrangements for departure by sea and air."

Netanyahu, addressing a Cabinet meeting on March 30 said, "Hamas will lay down its weapons. Its leaders will be allowed to leave. We will see to the general security in the Gaza Strip and will allow the realisation of the Trump plan for voluntary migration. This is the plan. We are not hiding this and are ready to discuss it at any time."

Netanyahu, in a public address on May 21 said Israel will create "a sterile zone in the southern Strip to which the civilian population will be evacuated from the combat areas, for

the purpose of defending it. In this zone, which will be Hamas-free, the residents of Gaza will receive full humanitarian assistance."

"I am ready to end the war, according to clear conditions that will ensure the security of Israel. All of the hostages will return home.

Hamas will lay down its weapons, leave power, its leadership, whoever is left, will be exiled from the Strip, Gaza will be completely demilitarized, and we will carry out the Trump plan, which is so correct and so revolutionary, and it says something simple: The residents of Gaza who wish to leave – will be able to leave," he iterated. # Indian tricolour hoisted atop Seattle's iconic Space Needle in historic first

NEW YORK/SEATTLE, AUG 16 /--/ The Indian tricolour was hoisted at Seattle's iconic 605-foot-tall Space Needle on India's 79th Independence Day, the first time that a foreign nation's flag was raised at the popular American destination.

Consul General of India in Seattle Prakash Gupta along with Mayor of Seattle Bruce Harrell and other select dignitaries from the Seattle city leadership joined the historic and landmark occasion.

"No greater honour than this! Raising the Tiranga on top of Seattle skyline at Space Needle," Gupta said in a post on X, along with a video of the tricolour flying high atop the iconic Seattle monument with sprawling views of the city below.

Calling the commemoration a "historic first in Seattle", the Consul General of India in Seattle said the celebration underscored the contributions of the Indian-American diaspora in shaping the city's journey as a tech hub in the US Pacific Northwest.

Later, a community reception was hosted by the Consul at the scenic Kerry Park, with India's flag on top of the

Space Needle in the backdrop. A large number of Indian-American community members turned up to witness the historic sight, the Consulate said in a press release.

The reception was attended by several dignitaries including US Congressman Adam Smith, Chief Justice of the Washington Supreme Court Debra Stephens, Seattle Port Commissioner Sam Cho and Superintendent/Director of Seattle Parks and Recreation AP Diaz.

Addressing the gathering, Smith welcomed the historic celebration, noting that the Indian tricolour's hoisting atop the Space Needle is a tribute to the region's diversity and the strong bonds between India and the Pacific Northwest.

The Space Needle, which was built in 1962, stands as a symbol of Seattle's skyline and epitomises the US Pacific Northwest region's tech-driven future.

In a special gesture to honour India's Independence Day in the Greater Seattle area, King County, which covers 39 cities, along with Seattle, Spokane, Tacoma and Bellevue, issued official proclamations marking August 15 as India Day.(PTI)

# China hands over third Hangor-class submarine to Pakistan

BEIJING, AUG 16 /--/ China has delivered the third of the eight new "advanced" Hangor-class submarines to Pakistan as part of Beijing's efforts to upgrade Islamabad's naval strength to support its growing presence in the Indian Ocean, India's backyard.

The launching ceremony of the third Hangor-class submarine was held in Wuhan, Central China's Hubei province, on Thursday, the state-run Global Times reported on Saturday.

The second of the eight submarines China is building for Pakistan was handed over in March this year.

This is in addition to four modern naval frigates that China supplied to Pakistan in the last few years as part of its efforts to boost Pakistan's naval strength amid the Chinese navy's steady expansion in the Arabian Sea, where it is developing the Gwadar port in Balochistan, as well as in the Indian Ocean.

Speaking at the launch of the third submarine, Pakistan's Deputy Chief of Naval Staff Project-2 Vice Admiral Abdul Samad said the Hangor-class submarine's cutting-edge weaponry and advanced

sensors would be instrumental in sustaining regional power equilibrium and ensuring maritime stability, the daily quoted a Pakistan defence statement as saying.

According to a recent report by the Stockholm International Peace Research Institute (SIPRI), China supplied over 81 per cent of Pakistan's military hardware.

Some of Pakistan's key orders in the past five years include the country's first spy ship, the Rizwan; more than 600 VT-4 battle tanks, and 36 J-10CE 4.5-generation fighters, according to the SIPRI database.

China supplied the first delivery of multi-role J-10CE fighter jets to the Pakistan Air Force in 2022, adding to its JF-17 fighters jointly manufactured by both countries. Pakistan used these fighter jets in the recent conflict with India.

Zhang Junshu, a Chinese military affairs expert, told the Global Times that the Hangor-class submarine is characterised by its strong underwater combat capabilities, including comprehensive sensor systems, excellent stealth characteristics, high mobility, long endurance and formidable firepower.(PTI)

# Death toll from flash floods rises to 307 in northwest Pak

PESHAWAR, AUG 16 /--/ The death toll from the recent flash floods in Pakistan's Khyber Pakhtunkhwa rose to over 300, with those killed also including 13 children, provincial authorities said on Saturday.

Torrential rains, which triggered flash floods in various districts of the province, are expected to continue intermittently until August 21, according to the Provincial Disaster Management Authority (PDMA).

PDMA Spokesman Faizi said that in the past 48 hours, 307 people were killed by the devastating rains, cloud bursts and flash floods.

In a preliminary report, the PDMA said that those killed include 279 men, 15 women, and 13 children. It said that 23 people were also injured, including 17 men, four women, and two children.

The affected districts include Bajaur, Buner, Swat, Manahra, Shangla, Torgar, and Batagram. Buner was the worst-hit, recording 184 deaths. Shangla reported 36 deaths, followed by Mansehra with 23, Swat 22, Bajaur 21, Battagram 15, Lower Dir five, while a child drowned in Abbottabad. A total of 74 houses have been damaged so far, of which 63 were partially and 11 completely de-

stroyed, the PDMA said. It added that relief teams and district administrations are in close coordination and are continuously monitoring the situation.

Relief funds have been released for flood-hit districts on the directives of the Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur.

He instructed all departments concerned to expedite rescue and relief operations in the affected areas.

Instructions have also been issued to mobilise all available resources for the restoration of blocked highways and link roads in tourist areas.

Tourists have been advised to remain updated on the weather conditions and take necessary safety precautions, PDMA said.

On Friday, the PDMA spokesperson had said that the number of those dead or injured was expected to rise further as scores of people were still missing in affected areas. Since late June, the beginning of monsoon season, torrential rains have wreaked havoc across the country – especially in Khyber Pakhtunkhwa and northern regions – deadly floods, landslides and displacement, particularly in vulnerable, poorly drained, or densely populated areas.(PTI)

# On Janmashtami, Yunus says committed to keeping bond of communal harmony 'unbroken'

DHAKA, AUG 16 /--/ Bangladesh's Chief Adviser Muhammad Yunus on Saturday greeted the country's Hindu community on Janmashtami, saying Lord Krishna's teachings will help strengthen "mutual goodwill and brotherhood" and maintain the nation's "existing order and communal harmony."

Yunus' greetings came amid widespread concerns over repeated incidents of alleged attacks on members of the Hindu community and their places of worship after he came to power in August last year.

In a message, Yunus said that Lord Krishna's values centred on "devotion to the creator and the

establishment of peace in society" continue to inspire people of all faiths, the state-run Bangladesh Sangbad Sangstha (BSS) reported.

"I call upon everyone to remain vigilant so that no one can undermine the existing order, fraternity, and communal amity in society. I believe that the ideals and teachings of Lord Sri Krishna will further strengthen the bonds of mutual goodwill and brotherhood," he said.

Yunus said that communal harmony is a "unique hallmark" of Bangladesh's culture and its people have practiced their respective religions while preserving "an enduring spirit of harmony"

for centuries.

He stressed that his interim government is "committed to keeping this bond of harmony unbroken". "Let us, through our collective efforts, build a new Bangladesh free from discrimination and enriched with communal harmony," Yunus added.

The relations between India and Bangladesh came under strain after the interim government headed by Yunus came to power last year in August.

India has been expressing concerns over attacks on minorities, especially Hindus, in the country. Janmashtami is a public holiday in Bangladesh to mark the birth celebration of Lord Krishna. (PTI)

# Data breach exposes thousands of Afghans settled in UK and British troops

LONDON, AUG 16 /--/ Thousands of Afghans, British troops and civil servants may have fallen victim to another data breach, according to a firm linked to the UK's Ministry of Defence. The Jet Centre, which provides ground handling for flights, said on late Friday that it suffered a data security incident which led to "unauthorised access to a limited number of company emails." About 3,700 individuals are thought to be potentially affected by the incident, including Afghans who were brought to the UK. Troops travelling to routine military exercises and journalists accompanying government ministers on official engagements are also among the potential victims. In a previous incident, some Afghans who fought alongside British forces before the Taliban swept back to power had their data leaked after an official released the details of 18,714 individuals "in error" in February 2022. Afghans who had worked with Western forces as fixers, translators and in other roles have sought refuge outside their country. Britain set up a programme, known as the Afghan Relocations and Assistance Policy, or ARAP, to bring some to the UK. (AP)
