In light of recent developments and reports pertaining to prevailing tensions in the Kashmir region of Jammu and Kashmir (“the UT”), the Company wishes to clarify that, as of the date of this communication, there has been no adverse impact on the Company’s business activities, project execution, or commercial engagements within the region as currently we don’t have any ongoing projects in the Kashmir region.

At present, majority of our ongoing projects are being carried outside the UT of Jammu and Kashmir and 100% of the current tendering is also being carried outside the UT of Jammu and Kashmir.

All operations and site-based activities under the Company’s purview are continuing in the normal course of business. The Company maintains robust risk assessment and mitigation protocols in line with industry standards and has not observed any disruption, delay, or force majeure condition attributable to the aforementioned external geopolitical developments.
