Steel Strips Wheels Limited (SSWL) is pleased to report its performance for July 2026 as below:-

- **July 2026 net turnover up 50.72% YoY and gross turnover up 43.11% YoY** — the highest monthly turnover ever recorded by the Company, by both value and volume, powered by broad-based growth across Aluminium, 2 & 3Wheeler, Truck and Tractor segments.

Highest-Ever Sales, By Both Volume and Value

July 2026 stands as SSWL's strongest month on record — record Rupee turnover and record wheel volumes, together — confirming this growth is demand-led, not merely price-driven.

- **Overall monthly sales:** up 51% YoY by value and 26% YoY by volume — the highest-ever monthly sales recorded by the Company.
- **Aluminium Segment:** highest-ever monthly volumes, up 38% YoY, reflecting accelerating premiumisation and OEM mix shift toward alloy wheels.
- **Tractor wheels:** highest-ever monthly volumes, up 10% YoY, adding a stable, less-cyclical growth leg to the portfolio.
- **Exports:** Export turnover grew 39% YoY by value, reflecting a continuing shift in the export mix toward value-added wheels (Aluminium and larger-size Steel wheels) and away from smaller, lower-value Steel wheels — driving higher realisation per wheel exported.
