Accordingly, there is no significant financial impact on the Company.</p> <p>The Company has filed the following details in the Information Memorandum filed with the Stock Exchanges alongwith listing application:</p> <p><i>"Comex filed a £543,501.07 breach of contract claim against Clearcomm on June 3, 2024, allegedly in retaliation to Clearcomm's £195,000.00 adjudication award. Comex claims involve various charges totaling £543,501.07. Clearcomm disputed the claim, submitted a counteroffer and attempted to strike out the claim. The claim was not struck out, leading to an agreement to sample 110 claims. There have been several delays by Comex in providing the required documentation and evidence for these sample claims, but Comex have now supplied a bundle of information which is currently being reviewed."</i></p>
