Sub: Intimation of Change in Registrar and Share Transfer Agent (“RTA”)

Pursuant to Regulation 30 read with Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI LODR”) / Para A Part A of Schedule III and SEBI master circular no. HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated 30th January 2026, we wish to inform you that the Board of Directors of the Company, by way of a resolution passed by circulation on July 31, 2026 has approved the appointment of **M/s. MUFG Intime India Private Limited (SEBI Registration No. INR000004058)** as the Registrar and Share Transfer Agent (“RTA”) of the Company, in place of the existing RTA, M/s.
