Sundaram Clayton Limited (SCL) commenced operations in World-Class Die-Casting Facility, Reports Strong Quarterly Growth

Chennai, Tamil Nadu, January 31, 2025: Sundaram Clayton Limited (SCL), a global leader in automotive aluminium die-casting components, commenced operations in its cutting-edge mega manufacturing facility in Thervoy Kandigai (TK), near Chennai in Tamil Nadu. The state-of-the-art plant will manufacture precision aluminium die-cast components for next-generation automotive applications, including advanced engine components, structural elements, and specialized lightweight solutions for electric vehicles.

The plant is among India's larger aluminium die-casting facilities and features cutting edge technology with advanced digital smart factory capabilities that will set new industry benchmarks for efficiency and productivity.

In a parallel development, SCL has enhanced its US operations with the successful commissioning of a 4,400-ton die-casting machine and thereby expanding its capability to serve the North American market with new product lines.

The launch of the TK facility and the commissioning of the 4,400 ton machine in US reflects SCL's commitment to innovation, sustainability, and customer satisfaction, and marks a key step in its ongoing efforts to further strengthen its operations and achieving further operating scale.

Today, Sundaram Clayton also announced its latest quarterly results, which reflect its operational excellence. Standalone EBITDA (excluding exceptional items) reached 14.7%, marking a quarter-on-quarter improvement of 1.3%. Consolidated EBITDA (excluding exceptional items) showed even stronger growth at 7.8%, up 4.4% from the previous quarter.
