I, M D Selvaraj, FCS, Managing Partner of M/s. MDS & Associates LLP, Company Secretaries, Coimbatore, have been appointed by the Board of Directors of **M/s. Super Spinning Mills Limited** ("the Company") as the Scrutinizer for the purpose of scrutinizing the remote e-voting process in a fair and transparent manner and for the purpose of ascertaining the requisite majority on the remote e-voting for postal ballot carried out in accordance with the provisions of Sections 108, 110 and other applicable provisions, if any, of the Companies Act, 2013 ("the Act") read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014 (as amended), Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and the General Circular No. 14/2020 dated 8<sup>th</sup> April 2020, General Circular No. 17/2020 dated 13<sup>th</sup> April 2020 read with other relevant circulars, including General Circular No. 9/2024 dated 19<sup>th</sup> September, 2024 issued by the Ministry of Corporate Affairs ("MCA Circulars") in respect of the Special Resolution as set out in the Postal ballot Notice dated 18<sup>th</sup> June 2025.



### Responsibility of the Management

The management of the Company is responsible to ensure compliance with the requirements of the Companies Act, 2013 and the Rules made thereunder in relation to exercising of voting rights through electronic means, on the resolution as set out in the Postal Ballot Notice dated 18<sup>th</sup> June 2025.

### Responsibility as a Scrutinizer

My responsibility, as a Scrutinizer for the Postal Ballot through remote e-voting process is restricted to the preparation of a Scrutinizer's Report on the votes cast "in favour" or "against" the resolution, as set out in Item No. 1 of the Postal Ballot Notice dated 18<sup>th</sup> June 2025, based on the reports generated from the e-voting system provided by M/s. MUFG Intime India Private Limited, the Authorized Agency, engaged by the Company for providing remote e-voting facilities.

Further, in addition to the above, I submit my report as under:

- a. The Postal Ballot Notice dated 18<sup>th</sup> June 2025 along with necessary statement setting out the material facts under Section 102 of the Companies Act, 2013 were sent on Monday, 23<sup>rd</sup> June 2025 through electronic mail to those members whose names appeared in the Register of Members / List of Beneficiaries as on Friday, 20<sup>th</sup> June 2025 ("cut-off date") and who had registered their email address with the Company / RTA / Depositories in compliance with the MCA Circulars. The Company has also placed the notice of the Postal Ballot on the website of the Company.
- b. The shareholders of the Company holding shares as on the "cut-off" date on Friday, 20<sup>th</sup> June 2025 were entitled to vote on the proposed resolution as set out in Item No. 1 of the said Postal Ballot Notice.
- c. The remote e-voting period remained open from Tuesday, 24<sup>th</sup> June 2025 at 9:00 AM (IST) till Wednesday, 23<sup>rd</sup> July 2025 at 5:00 PM (IST) (both days inclusive). During the said period, the members of the Company holding shares in physical and / or in dematerialized form, as on the cut-off date i.e. 20<sup>th</sup> June 2025 were entitled to vote on the resolution set out in the notice of postal ballot through remote e-voting.



- d. The e-voting module of MUFG Intime India Private Limited was disabled on Wednesday, 23<sup>rd</sup> July 2025 at 5:00 PM (IST) and I, as the Scrutinizer, unblocked the votes cast, on Wednesday, 23<sup>rd</sup> July 2025 at 5.14 PM (IST) in the presence of Mr. Sheshanth P B and Ms. S. Poornima, who are not in employment of the Company in accordance with Rule 20(4)(xii) of the Companies (Management and Administration) Rules, 2014 (as amended).
- e. I have scrutinized the remote e-voting for the postal ballot and the votes tendered therein and maintained registers in which necessary entries have been made in accordance with the Companies (Management and Administration) Rules, 2014 (as amended).
