With reference to the captioned subject, this is to inform you that the Company has received notices from BSE and NSE Limited through email both dated 29th August, 2025 respectively imposed a fine of ₹2,80,000/- plus applicable GST, each for delayed compliance of regulation 17(1) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (referred to as SEBI Listing Regulations).

At the outset, we wish to inform you that the Board of Directors has on 17th July, 2025 appointed Mr. Ravi Kant Gupta having DIN- 03111902 as an Additional Director (Non-Executive; Independent) on its Board, subject to approval of shareholders at the Annual General Meeting of the Company to be held on 18<sup>th</sup> September, 2025. The intimation in this regard was filed with the exchanges on 17<sup>th</sup> July, 2025 under Regulation 30 of the SEBI Listing Regulations. Accordingly, the Company has complied with the provisions of Regulation 17(1) of the SEBI Listing Regulations with respect to appointment of Independent Director with certain delay.

In reference to the above, it is deemed pertinent to inform you that the Company's Board of Directors comprises of extremely qualified and reputable personalities, wherein finding a suitable Independent candidature possessing such repute and required skill set (as per Schedule V of Listing Regulations) and appointment on the Board was challenging and time-consuming task.
