We would like to inform that in accordance with the Trading Plan submitted to the Stock Exchanges vide Bank's Letter No.: SSFB/CS/80/2025-26 dated November 13, 2025, Mr. Baskar Babu Ramachandran, the Promoter and Managing Director & CEO of the Bank, has purchased 50,000 Equity Shares of the Bank from open market during March 17, 2026 (14,000 Shares) and March 18, 2026 (36,000 Shares).

Post the said transaction, the total Promoters and Promoters' Group holding in the Bank shall stand at 22.48% (earlier 22.44%) and Mr. Baskar Babu Ramachandran's individual holding shall stand at 5.22% (earlier 5.18%). It is further confirmed that the holding of the Promoters is in compliance with the applicable regulatory provisions and in line with the RBI pre-approved limits.
