Pursuant to Regulation 29(2) of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, we hereby submit the enclosed disclosure in respect of the change in our shareholding in Suven Life Sciences Limited since the last disclosure made under the aforesaid Regulations. The change has arisen consequent to the allotment of 2,71,970 equity shares of Re. 1/- each pursuant to the exercise of vested stock options under the Suven Life Employee Stock Option Scheme, 2020, and the preferential allotment of 1,85,70,133 equity shares upon conversion of fully paid-up warrants issued to certain identified non-promoter persons/entities. As a result of the increase in the paid-up equity share capital of the Company, our shareholding has been diluted from 70.15% to 65.47% of the voting share capital since the last disclosure.

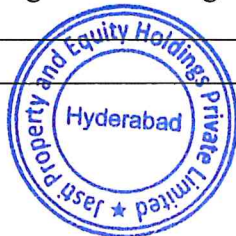

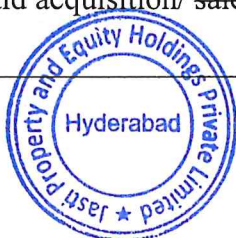

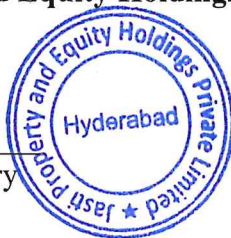
