Subject : Revised Intimation regarding loss of records due to fire incident under Regulation 30 of SEBI (LODR) Regulations, 2015

Dear Sir/Madam,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that a fire incident occurred at our Plant office/warehouse/records storage facility located at Plot No SP - 2 Industrial Area, Dhanodi, Jhalawar – 326 001, Rajasthan, on 25.08.2025 at midnight.

Due to this unforeseen incident, several physical records and documents maintained at the said premises have been damaged/burnt and are no longer retrievable. The Company is currently assessing the extent of the loss and is taking necessary steps to recover and reconstruct the lost data and documents to the extent possible.

We have also reported the incident to the local authorities and filed a First Information Report (FIR). A copy of the FIR and preliminary report is enclosed herewith for your reference.

We will keep the exchange informed of further developments in this regard.


