Sub.: Outcome of Board Meeting held on Tuesday, 25th November 2025

Ref: Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) ("LODR") Regulations, 2015

In continuation of our letter dated November 18, 2025 and pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015 ("Listing Regulations"), the Board of Directors of the Company at its meeting held on today i.e., 25th November 2025, the Board of Directors has inter alia considered & approved the following:

- 1. Issuance of up to 43,76,500 (Forty Three Lakh Seventy Six Thousand Five Hundred) Equity Shares at a face value of Rs. 10/- (Rupees Ten) per share on a preferential basis ("Preferential Issue") in accordance with Chapter V of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 ["SEBI (ICDR) Regulations"], as amended, and other applicable laws, at the issue price of Rs. 236/-(Rupees Two Hundred Thirty Six) per share, aggregating up to Rs. 1,03,28,54,000/-(Rupees One Hundred Three Crores Twenty Eight Lakhs Fifty Four Thousand only) to Identified Persons, subject to the approval of the members of the Company and such regulatory/ statutory authorities as may be applicable. The information in connection with the Preferential Issue as per Master Circular no. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023 & SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 is enclosed as Annexure-I.
- 2. Issuance of up to 67,97,000 (Sixty Seven Lakh Ninety Seven Thousand) Warrants convertible into equal number of Equity Shares at a face value of Rs. 10/- (Rupees Ten) per share on a preferential basis ("Preferential Issue") in accordance with Chapter V of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 ["SEBI (ICDR) Regulations"], as amended, and other applicable laws, at the issue price of Rs. 236/- (Rupees Two Hundred Thirty Six) per warrant, aggregating up to Rs.1,60,40,92,000/- (Rupees One Hundred Sixty Cores Forty Lakh Ninety Two Thousand) to Promoter/ Promoter group/ Identified Persons, subject

















to the approval of the members of the Company and such regulatory/ statutory authorities as may be applicable. The warrants shall be convertible into equal number of equity shares on conversion. The information in connection with the Preferential Issue of warrants as per Master Circular no. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023 & SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 is enclosed as **Annexure-II** to this letter.

- 3. To advance any loan or give any corporate guarantee or provide security in connection with any loan taken by any person in whom/which any of the Directors of the Company is interested as specified in the explanation to section 185(2) of the Companies Act 2013, subject to the approval of the members of the Company, of an aggregate amount not exceeding Rs. 75,00,00,000/- (Rupees Seventy Five Crores Only).
- 4. To increase the Borrowing Power under Section 180(1)(c) of the Companies Act, 2013, subject to the approval of the members of the Company, up to an aggregate amount of Rs. 1000 Crores (Rupees One Thousand Crores) where the monies to be borrowed, together with the monies already borrowed by the Company may exceed the aggregate, for the time being, of the paid up share capital of the Company and its free reserves, that is to say, reserves not set apart for any specific purpose.
- 5. To increase the limit to create charge/ mortgage/ hypothecation on the immovable and movable properties of the Company under Section 180(1)(a) of the Companies Act, 2013, subject to the approval of the members of the Company, up to Rs. 1000 Crore (Rupees One Thousand Crore).
- 6. To Convene an Extra-Ordinary General Meeting of the Members of the Company on Wednesday, the 24th of December 2025 for seeking their approval for the Preferential Issue and the other items discussed and considered in this meeting. The Notice of the said EGM shall be submitted to the Stock Exchange in due course in compliance with the provisions of the SEBI (LODR) Regulations and SEBI (ICDR) Regulations.

The meeting commenced at 05:30 PM and concluded at 07:05 PM
