Pursuant to Regulation 30 of the SEBI Listing Regulations read with Clause 20 of Para A of Part A of Schedule III thereof, this is to inform that Swiggy Limited (“Company”) had received a Prohibition Order (“Order”) dated July 6, 2026 from the Food Safety and Standards Authority of India (“FSSAI”) in relation to the Company’s food ordering and delivery platform / application “Toing”.

The matter related to certain observations by FSSAI regarding updation of licence particulars and involved no food safety concerns.

Accordingly, the Company has addressed the observations forming the basis of the Order and has since received the modified FSSAI licence on July 09, 2026.
