Subject: Disclosure of the details of allotment in the Issue (as defined hereinafter) by Swiggy Limited (the “Company”) in accordance with the Securities and Exchange Board of India (Listing Obligations and Disclosures Requirements), 2015, as amended (the “SEBI Listing Regulations”).

Ref: Qualified institutions placement of equity shares of face value ₹1 each (the “Equity Shares”) by the Company under the provisions of Chapter VI of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the “SEBI ICDR Regulations”), and Sections 42 and 62(1)(c) of the Companies Act, 2013, including the rules made thereunder, each as amended (the “Issue”).

In continuation of our earlier letters on the captioned subject we wish to inform you that, the Investment & Allotment Committee of the Board (the “**Investment & Allotment Committee**”) at its meeting held today i.e. December 13, 2025 approved the issue and allotment of 26,66,66,663 Equity Shares to eligible qualified institutional buyers at an issue price of ₹375.00 per Equity Share (including a premium of ₹374.00 per Equity Share), which includes a discount of 3.97 % of the floor price of ₹ 390.51 per Equity Share (amounting to ₹ 15.51 per Equity Share), as determined in terms of the SEBI ICDR Regulations), aggregating to ₹ 99,99,99,98,625 (Rupees Nine Thousand Nine Hundred Ninety-Nine crore Ninety-Nine Lakh Ninety-Eight Thousand Six Hundred and Twenty Five only), pursuant to the Issue.

The Issue opened on December 09, 2025, and closed on December 12, 2025.

Pursuant to the allotment of Equity Shares in the Issue, the paid- up equity share capital of the Company stands increased from ₹2,49,36,46,892 comprising of 2,49,36,46,892 Equity Shares of ₹1 each to ₹ 2,76,03,13,555 comprising of 2,76,03,13,555 Equity Shares of ₹ 1 each.
