As you are aware, we were appointed as the Statutory Auditors of Syngene Scientific Solutions Limited ('the Company'), pursuant to the shareholder's resolution dated 21 July 2023 to hold office until the conclusion of the 6<sup>th</sup> Annual General Meeting of the Company to be held after the end of financial year ending 31 March 2028.

We have completed our statutory audit till 31 March 2026 and we issued our audit report on 28 April 2026.

Please refer to our ongoing discussions in connection with our continuation as statutory auditors of the Company. As per discussions, management intends to align auditors with the auditors of Syngene International Limited, the holding company, due to mandatory rotation of our firm as auditors of the holding company under the Companies Act, 2013. In view of the above, we would not be in a position to continue as statutory auditors of the Company for the year ended 31 March 2027. We have also discussed this matter with the Management of the Company.

As per the requirement of the Companies Act, 2013, we shall be forwarding the copy of the ADT-3, as filed with ROC, in due course.


