**Subject: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”), sub-para 20 of Para A of Part A of Schedule III and In continuation with our letter (Ref: SSPSL /SEC /2025-26/Dec/01) dated 01<sup>st</sup> December 2025, we wish to inform that:

The BSE Limited and NSE Limited levied a penalty of Rs.3,28,040/- each, inclusive of GST, on the Company for a non-compliance with Regulation 19(1) and (2) of the Listing Regulations relating to the composition of the Nomination and remuneration committee. In connection with that, the Company submitted a waiver application to BSE Limited.

The Company has received an email communication dated April 08, 2026, from BSE Limited, intimating that the waiver application has been rejected.

Further to that, we have paid the fine amount to BSE Limited on 09<sup>th</sup> April 2026.

The Company further confirms that the composition of the nomination and remuneration committee is in compliance with Regulation 19(1) and (2) of the Listing Regulations as on date and continues to remain compliant thereafter.
