TN Govt cracks down on illicit liquor violations

Chennai, May 24: Tamil Nadu Minister for Prohibition and Excise K. Vignesh warned of strict action against individuals involved in the manufacture, transportation and sale of illicit liquor, as well as officials found supporting such illegal activities.

The Minister issued the warning while chairing a review meeting at the Prohibition and Excise Department Headquarters in Chennai. During the review, K. Vignesh discussed the functioning of the

department and the implementation of excise-related activities across districts. He instructed district-level officers to conduct regular field inspections to ensure that recreational clubs operating under FL2 license strictly follow rules and regulations.

The Minister directed field officials to intensify surveillance measures and completely curb illicit liquor activities across the state. Excise supervisory officers were also instructed to ensure that liquor manufacturing units function within legal guidelines.

Emphasizing public safety, the Minister called for increased awareness campaigns against illicit liquor, counterfeit liquor

and narcotic substances. He also ordered surprise inspections to identify and eliminate illegal activities. K. Vignesh reiterated

that the government would not tolerate violations and warned that stringent action would be taken against both offenders and officials found enabling unlawful activities. Commissioner of Prohibition and Excise S.P. Karthika, Joint Commissioner-I, Assistant Commissioners and other senior officials attended the meeting.
