In reference to the approval of the issue of Equity Shares through Preferential Allotment by the Board of Directors in its meeting dated September 4, 2025, and by the Members in the Annual General Meeting dated September 29, 2025, the Company has duly submitted an Application for In-Principle Approval to the NSE on September 6, 2025, for the issue of Equity Shares through Preferential Allotment.

Subsequent to observations from the National Stock Exchange (NSE) dated November 26, 2025, the Company wishes to inform the Stakeholders about the following correction in AGM Notice of the Company dated September 4, 2025.

In Annexure – A - Pre and Post Preferential Issue Shareholding Pattern of the Company, the total of the Post-Preferential Issue Shareholding Pattern under the Non-Institutional Category (B3), as disclosed in the Explanatory Statement of resolution no. 6 of the AGM Notice, is 61,18,347 instead of 64,01,947.

Further the total of the Post-Preferential Issue Shareholding Pattern under the Individual shareholders holding nominal share capital up to Rs. 2 Lacs Category [B3(a)] is 36,67,100 instead of 37,65,147 and holding nominal share capital in excess Rs. 2 Lacs Category [B3(a)] is 12,13,647 instead of 11,15,600 as disclosed in the Explanatory Statement of resolution no. 6 of the AGM Notice.

Please note that no other changes have been made to the shareholding pattern apart from the corrections mentioned above.
