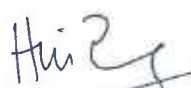

(#) Please note that as per the last disclosure made by GIC under Regulation 29(2) of the SEBI Takeover Regulations dated 26 March 2024, GIC held 26,704,324 equity shares (7.11%) of the TC computed basis the outstanding share capital of the TC (as per announcement on the Exchange on 11 March 2024). Since then, GIC has sold equity shares of the TC in multiple non-reportable (by GIC to the stock exchanges) tranches and certain non-reportable passive changes in the TC share capital have also occurred. On 9 April 2026 GIC had in aggregate sold such number of equity shares of the TC that, after taking into consideration the non-reportable passive changes, the disclosure requirement under Regulation 29(2) of the SEBI Takeover Regulations was triggered with respect to the change in shareholding of GIC in the TC and accordingly the present disclosure under Regulation 29(2) of the SEBI Takeover Regulations is being made.
