Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Update on material litigation

This is with reference to our disclosure dated August 14, 2023 and subsequent updates submitted as part of the Quarterly Integrated Filing (Governance), in relation to certain ongoing income-tax litigations involving Tata Communications Limited ("Company").

As an update to the matter, the Company wishes to inform that the Income Tax Appellate Tribunal, Mumbai ("ITAT") has, vide its order dated September 25, 2026, disposed of the cross-appeals filed by the Company and the Income-tax Department for Assessment Year 2011-12. The ITAT has granted relief to the Company on various matters, including the Company's claim for deduction under section 80-IA of the Income-tax Act, 1961 in respect of its National Long Distance undertaking and certain Transfer Pricing and other tax matters. Certain matters are subject to consequential verification / recomputation by the Assessing Officer.

The Company is evaluating the order, including the consequential tax impact and further course of action, if any.
