In this context, we wish to inform you that the Allotment Committee of Tata Motors Passenger Vehicles Limited (*formerly Tata Motors Limited*) (‘the Company’) as authorized by the Board of Directors of the Company, has at its Meeting held today, *i.e.*, February 18, 2026, approved allotment of 46,190 Ordinary/Equity Shares of the face value of ₹2/- each fully paid up under the Scheme to the eligible employees pursuant to exercise of 46,190 Performance Share Units at an exercise price of ₹2/- per share.

Consequent to the aforesaid allotment, the paid-up Ordinary/Equity Share Capital of the Company stands increased from ₹7,36,51,40,251 divided into 3,68,23,31,373 Ordinary/Equity Shares of ₹2/- each to ₹7,36,52,32,631 divided into 3,68,23,77,563 Ordinary/Equity Shares of ₹2/- each (considering the amount of subscribed share capital plus shares forfeited less calls in arrears).

The aforesaid Ordinary/Equity Shares shall rank *pari passu* in all aspects with the existing Ordinary/Equity Shares of the Company.
