I, Himanshu Gupta, Proprietor of M/s. The management of the company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules thereunder relating to remote e-voting or by way of poll voting at AGM. My Responsibility as a scrutinizer for the voting process is restricted to preparing a Scrutinizer's Report of the votes casted "in favour" or "against" the resolution(s) based on the reports generated from the Remote E-voting system provided by **National Securities Depository Limited (NSDL)** (the Agency/service provider) authorized and engaged by the company for that purpose and the Physical polling papers received from the shareholders/members at the AGM of the company.

I submit my report as under:

- i. The Shareholders of the company holding shares as on the "cut-off" date **Saturday, September 19, 2026**, whose names were recorded in the Register of Members or in the Register of Beneficial Owners maintained by the Depositories were entitled to vote on the proposed resolutions as set out in item nos. 01 to 04 in the notice of the AGM of TBI Corn Limited dated **Thursday, 03<sup>rd</sup> September, 2026**.

- ii. The notice of AGM along with Annual Report was mailed electronically to the members who had registered their emails with the depositories. Further, the company has provided the option of poll voting to the members who have attended the AGM of the company on **Saturday, 26<sup>th</sup> September 2026**.
- iii. The facility provided for E-voting commenced from **09:00 A.M. on Wednesday, 23<sup>rd</sup> September, 2026** and ended on **05:00 P.M. on Friday, 25<sup>th</sup> September, 2026**. The E-voting facility was blocked thereafter.
- iv. At the venue of the AGM the facility to cast the vote by poll was provided to facilitate those members present at the AGM and after the announcement made for the closing of the polling process by the chairman, Ballot Box kept for the polling were locked in my presence with due identification marks placed by me.

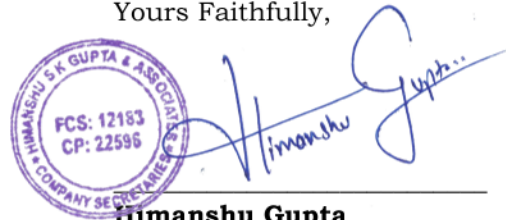
