Re: ICRA rating for Rs. 25.0 crore Commercial Paper of TCI Express Limited

Please refer to your request dated November 4, 2024, for revalidating the rating letter issued for the captioned programme.

We confirm that the short-term rating of **[ICRA] A1+** (pronounced as ICRA A one plus)[†] assigned to your captioned Commercial Paper programme and last communicated to you vide our last letter dated September 11, 2024, stands. Instruments with [ICRA]A1 rating indicate very strong degree of safety regarding timely payment of financial obligations. Such instruments carry lowest credit risk. Within this category, rating modifier {"+" (plus)} can be used with the rating symbols. The modifier reflects the comparative standing within the category.

We wish to highlight the following with respect to the Rating:

- (a) If the instrument rated, as above, is not issued by you within a period of 3 months from the date of this letter, the rating would need to be revalidated before issuance.
- (b) Subject to Clause (c) below, once the instrument is issued, the rating is valid throughout the life of the captioned programme (which shall have a maximum maturity of twelve months from the date of the issuance of the instrument).
- (c) Notwithstanding anything contain in clause (b) above, ICRA reserves the right to review and/or, revise the above rating at any time on the basis of new information or unavailability of information or such circumstances, which ICRA believes, may have an impact on the aforesaid rating assigned to you.

The rating, as aforesaid, however, should not be treated as a recommendation to buy, sell, or hold CP issued by you. The rating is restricted to your CP programme size of Rs. 25.0 crore only. In case, you propose to enhance the size of the CP programme, the same would require to be rated afresh.
