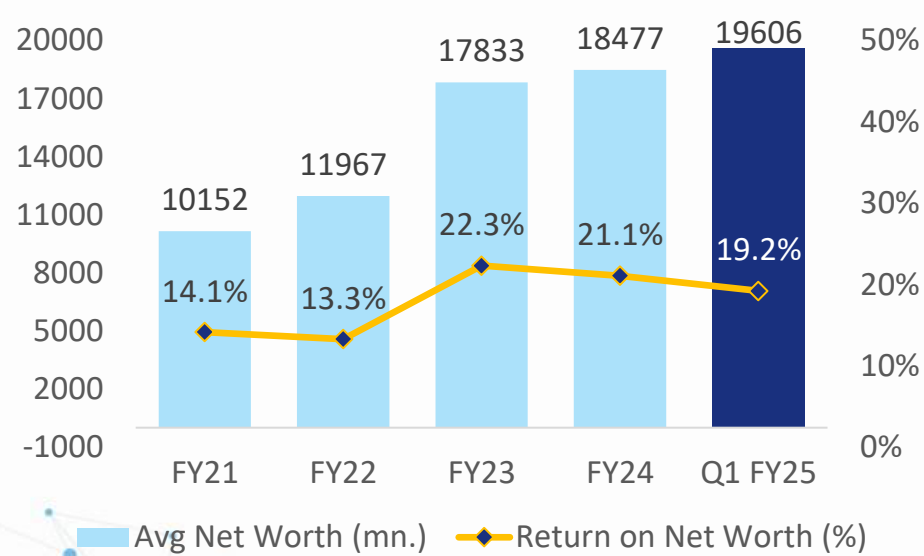
Return on Capital Employed



Consolidated Profit After Tax



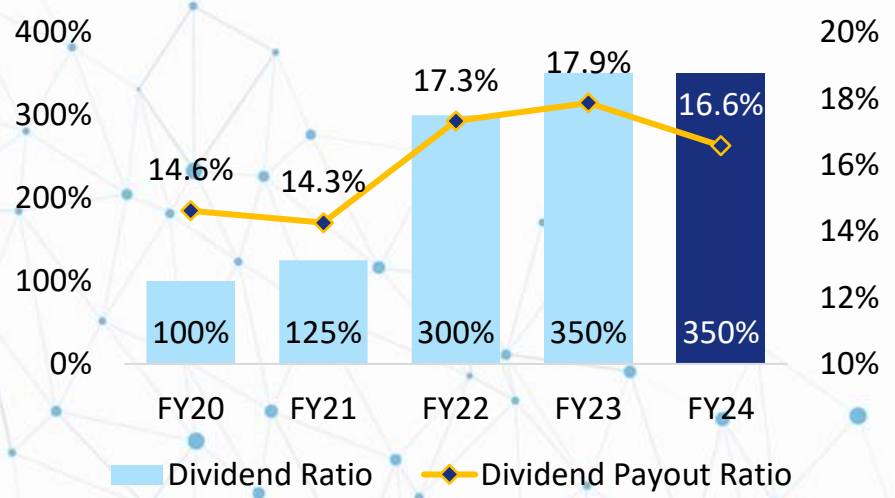
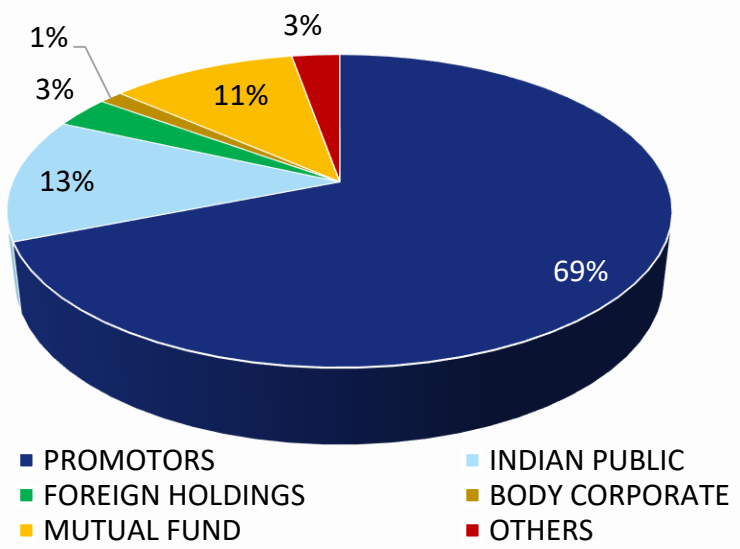
