Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Receipt of Notice of Strike

Pursuant to Regulation 30 of the SEBI (LODR) Regulations, 2015, we inform you that a strike notice has been issued by the Workers' Union to take effect on or after September 3, 2025, demanding reinstatement of four dismissed workmen and a few who are under suspension.

The dismissals were carried out after the charges of serious misconduct were proved through extensive enquiry processes and those under suspension are undergoing lawful enquiry processes for serious misconduct. As such, the call for a strike is considered inappropriate. The Company is in the process of applying for an injunction order in this regard and is taking all necessary measures to resolve the matter and ensure uninterrupted operations. Further updates will be provided in due course.

Impact on business is insignificant as the strike is only by a section of workers which represent approx. 9.8% of the Company's total workforce including contract workmen.

The details required to be furnished pursuant to Regulation 30 of the Listing Regulations read with the SEBI SEBI/HO/CFD/CFD PoD- 1/P/CIR/2023/123 dated July 13, 2023 are enclosed as Annexure-A.
