The matter, which was listed for hearing on September 22, 2026, remained at the notice stage. The Hon'ble Court received the reply submitted by the Respondents, and accordingly, the matter has been adjourned and is now listed for the next hearing on November 30, 2026.

An affidavit-in-reply has been filed by the Regional Provident Fund Commissioner-I, Employees' Provident Fund Organisation, Vadodara, on behalf of Respondent Nos. 4 and 5 in Special Civil Application No. 7698 of 2026 titled M/s. TeamLease Skills University vs. Union of India & Ors. pending before the Hon'ble High Court of Gujarat.

In the affidavit, the EPFO has, inter alia, reiterated its position that trainees engaged under the National Employability Enhancement Mission (NEEM) framework are covered within the definition of "employee" under Section 2(f) of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952 and has sought to justify the order dated 11 March 2026 passed by the Regional Provident Fund Commissioner.

TeamLease Skills University strongly disagrees with the assertions made in the affidavit and continues to pursue its legal remedies before the Hon'ble High Court of Gujarat. The University believes that it has a strong case on merits and had challenged the underlying order through the aforesaid writ proceedings.

The matter remains sub judice and is currently pending adjudication before the Hon'ble High Court of Gujarat.

The Company will continue to keep the stock exchanges informed of any material developments in accordance with applicable regulatory requirements

Annexure B

Update to the Note 46.7 of the Consolidated Financial Statements for FY25

TeamLease Skills University (TLSU) is a Public Private University and is India's first vocational education and training university, established in Gujarat in 2013. It focuses on providing skills-based education aimed at improving employability. TeamLease Foundation (formerly known as TeamLease Education Foundation) is a subsidiary of TeamLease Services Limited and acts as a sponsoring body of TLSU.

Department of Higher Education, Ministry of Education (formerly known as Ministry of Human Resource Development) launched National Employability Enhancement Mission (NEEM) scheme under the All India Council of Technical Education dated April 15, 2013, and as per the amended NEEM Guidelines dated June 15, 2017 the trainees under this scheme would not be employees for the purpose of Provident Fund (PF), Employee State Insurance (ESI) and any other social security legislations. The relevant clause is re-produced for reference:

“15.2 Remuneration/ Stipend shall be paid as a single consolidated amount and such payment will not attract any statutory deductions or payments applicable to regular employees i.e. PF/ESI etc., since the NEEM contract assures training and does not constitute employment.”

TeamLease Skills University (TLSU) registered under Gujarat Private Universities Act, 2009 deployed NEEM trainees to various client locations through a duly authorised NEEM agent, in accordance with the NEEM Scheme.

The EPFO authorities have taken a view that NEEM trainees should be treated as “employees” under the provisions of the Employees’ Provident Funds and Miscellaneous Provisions Act, 1952 (“EPF Act”) and initially proposed to initiate proceedings under Section 7A of the EPF Act, which pertains to assessment and determination of Provident Fund dues.

TLSU represented before the EPFO that before initiation of any assessment under Section 7A, it was necessary to first determine the applicability of the EPF Act itself to NEEM trainees. Based on this representation, the proceedings were thereafter initiated under Paragraph 26-B of the EPF Scheme, 1952, which specifically deals with determination of applicability of the EPF Act.

It may be noted that the NEEM Scheme expressly excluded NEEM trainees from being classified as “employees” for the purposes of statutory social security legislations, including Provident Fund and Employee State Insurance, and this forms a key ground of challenge.
