This is further to our earlier disclosure dated 11.08.2026 intimating the Exchange of the admission of Teerth Gopicon Limited ("the Company") into Corporate Insolvency Resolution Process ("CIRP") vide order dated 10.08.2026 passed by the Hon'ble National Company Law Tribunal, Ahmedabad Bench, in CP(IB)/408(AHM)2025, and the consequent appointment of the undersigned as Interim Resolution Professional of the Company.

We wish to inform the Exchange that the Hon'ble National Company Law Tribunal, Ahmedabad Bench, Court-2, has passed an order dated 10.09.2026 in IA/1483(AHM)2026 filed in the aforesaid Company Petition. Particulars of the order, furnished in terms of Para A of Part A of Schedule III to the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, are set out below.

The application was filed by one of the erstwhile Whole-time Directors of the Company (presently a member of the Suspended Board of Directors), seeking, inter alia, a stay of further steps in the Corporate Insolvency Resolution Process ("CIRP") of the Company and recall of the order dated 10.08.2026 admitting the Company into CIRP, on the stated ground that the applicant became aware of the admission only at a later stage. The Hon'ble Tribunal noted that no appeal against the order dated 10.08.2026 had been preferred by the applicant under Section 61 of the

Insolvency and Bankruptcy Code, 2016, and held that the application was not maintainable for want of the applicant having availed the appropriate remedy available in law. The Hon'ble Tribunal rejected the application accordingly and disposed of IA/1483(AHM)2026.

Heard Ld. Counsel for the Applicant. It is submitted that the present application has been filed seeking directions to stay all further steps in the CIRP proceedings pursuant to the order dated 10.08.2026. This application is filed under Rule 11 read with Rule 154 of NCLT Rules 2016, read with Sec 60(5) (c) of IBC 2016 and Sec 424 (1) of Companies Act 2013.

The applicant is Ex Director of the Company, stating that she came to know of admission to CIRP only after later stage. No appeal was made against the order of this tribunal under Sec 61 of IBC 2016 till date but the Ld Counsel for applicant seeks various reliefs including recall the order dated 10.08.2026 passed in CP IB No.408/2025. It is also submitted that the application for initiating CIRP was filed on 16.10.2025 and notices were issued, matter was heard and the CIRP was admitted. The Ld Counsel for IRP appeared in person and submitted that the COC has already been constituted. The applicant has not stated any reason why they did not appear
