Even Mr. Mukherjee himself has admitted the violations alleged. Hence, in view of the current circumstances, the Committee provided relaxation from imposing any penalty upon him and served a warning vide letter dated October 23, 2025 forewarning not to commit any violation under 'Tega Insider Code'. The above decision of the SRC was communicated to the Designated Person vide letter dated October 23, 2025.
