Dear Sir/ Madam,

We refer to our disclosure dated November 29, 2025 (“**November 29 Disclosure**”) where we had inter alia made disclosures regarding execution of a share subscription agreement by Tega MC Investment Pte. Ltd. (“**Tega HoldCo**”) (Company’s wholly owned subsidiary), Tega MC SG Investments I Pte. Ltd. (“**RPS Company**”), AP Jupiter Holdco (SG) Pte. Ltd. (“**Apollo HoldCo**”) and Tega MC JV Holdings Pte. Ltd. (“**SG Company**”) on November 28, 2025 (“**SSA**”).

Pursuant thereto and pursuant to Regulation 30 read with Paragraph A of Part A of Schedule III of the SEBI Listing Regulations, we would like to inform you that Tega HoldCo has exercised its Upsize Option (defined in the November 29 Disclosure) and has elected to increase its subscription amount by USD 35 million, for additional investment in ordinary shares of SG Company. Accordingly, (a) Tega HoldCo will now invest a total of USD 394,295,423 for a total of 394,295,423 ordinary shares of SG Company and upon completion of the investment hold ~84.2% of the total ordinary shareholding of the SG Company, and (b) Apollo HoldCo will now invest a total of USD 74,107,477 for a total of 74,107,477 ordinary shares of SG Company and upon completion of the investment hold ~15.8% of the total ordinary shareholding of the SG Company.

There will be no change to the amount of USD 270,00,000 to be invested by Apollo HoldCo in redeemable preference shares of RPS Company, as mentioned in the November 29 Disclosure.

Kindly take this intimation on your record. We request that the same be treated as compliance under Regulation 30 of SEBI Listing Regulations, and other applicable provisions of the SEBI Listing Regulations.
