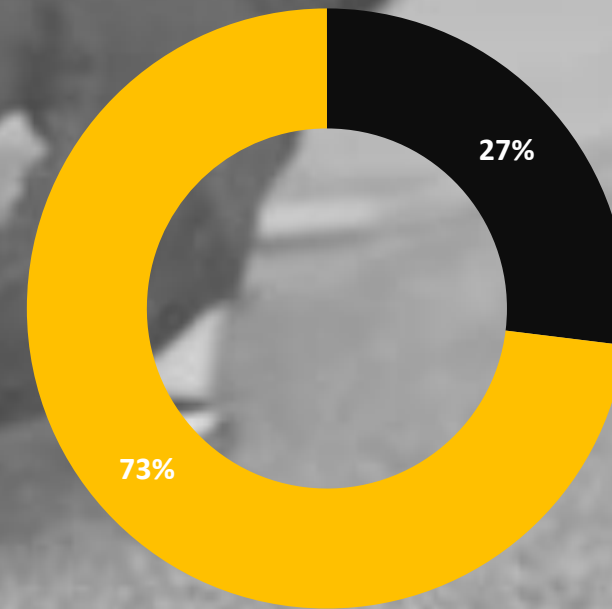
REVENUE SPLIT FY23 AND H1FY24

- To grow the textile division of Company, we have initiated the exports of yarn in current financial year. This will boost the top & the bottom line of textile segment of the Company.
- Planning to set-up a textile mill and will start in-house manufacturing of yarn in 3 years down the line.

The proposed expansion is under progress and will be commissioned in FY25.

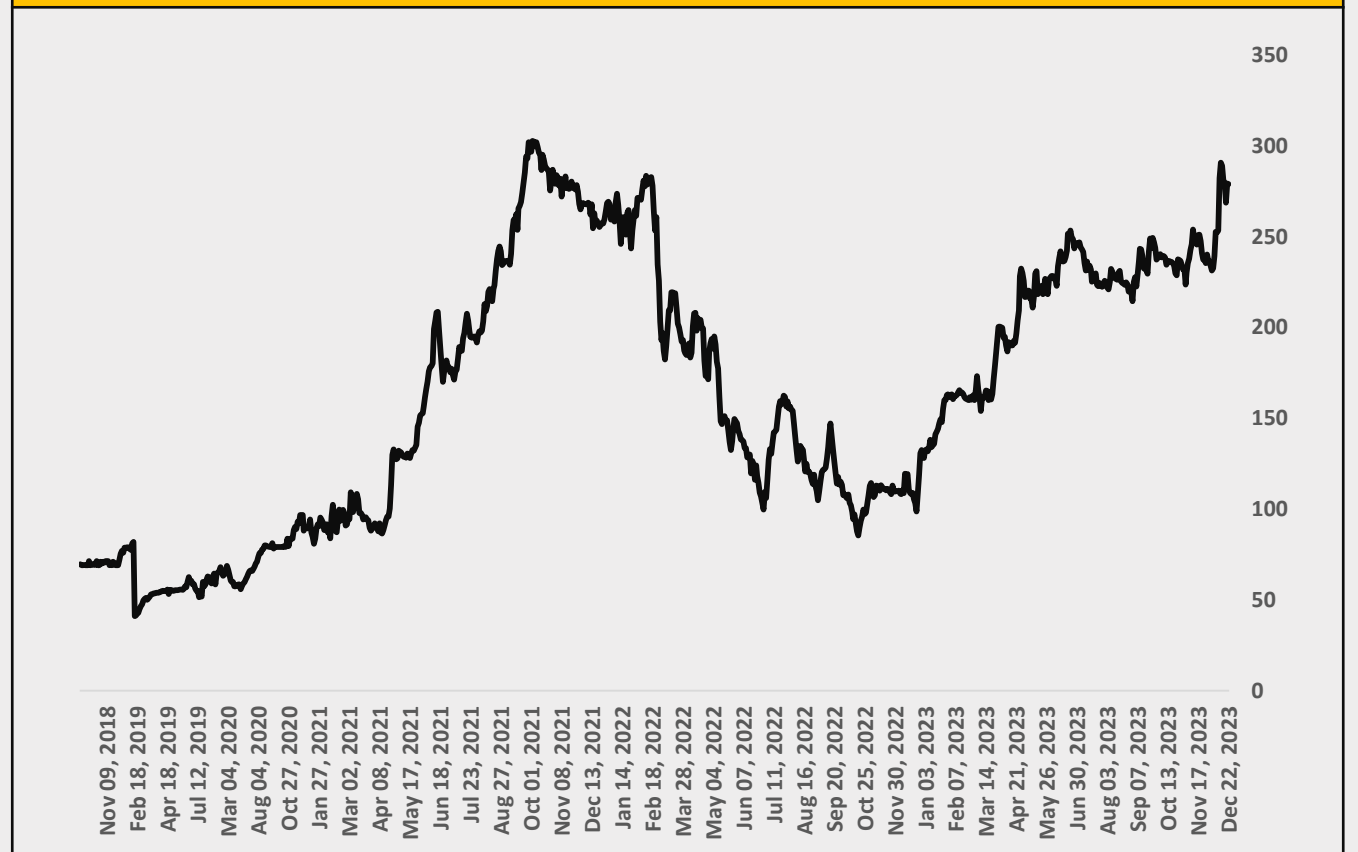
