Sub: Disposal of Writ Petition in connection with GST Demand Order.


Ref: WP/0006870/2026 dated 10-03-2026 filed against GST Demand Order (DRC-07) dated 15-11-2025.

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform you that the Writ Petition filed by the Company against the GST Demand Order passed by the Assistant Commissioner, Tenali, Commercial Taxes Department, Government of Andhra Pradesh, has been disposed of without costs by the Hon'ble High Court of Andhra Pradesh.
