1991 Anantnag blast absconding accused held by Jammu Rly Police

SRINAGAR

After 35 years, the Government Railway Police (GRP) Jammu said on Thursday that it has arrested the 1991 bomb blast accused from Jammu and Kashmir's Anantnag district, officials said.

Officials added that the Railway Police Jammu have arrested the 1991 bomb blast accused from the Anantnag district, who had been absconding for 35 years.

The arrested person has been identified as Altaf Hus-sain Sheikh, the son of Nazir Ahmed Sheikh and a resident of Marhama-Bijbehara in Anantnag.

He was booked under the Terrorist and Disruptive Activities (Prevention) Act.

An FIR under Sections 307, 302, 120(B) of the Ranbir Penal Code, Section 3/4 of Terrorist and Disruptive Activities (Prevention) Act (TADA) and Sec-

He was involved in a blast that took place on April 2, 1991, at Platform number 1 of the Jammu Railway Station. The explosion killed three persons, including two paramilitary personnel, and injured 18 civilians, officials said.

tion 4/5 of the Explosive Substances Act was registered at the GRP Jammu Police Station in connection with the case.

During the investigation, one accused Aman Ullah Khan was arrested. Three others managed to escape and were later declared absconders by the court.

Police said that in the last two years, GRP Jammu launched an intensive man-hunt.

The team traced Altaf Hus-sain Sheikh, verified his identity and found that he had been living under a concealed ident-



ity for decades.

He had reportedly established himself as a businessman in the Bijbehara area.

Following the long pursuit, the accused was arrested and produced before the TADA Court on Thursday for further legal proceedings.

Officials said the arrest was made possible due to sustained efforts to track down absconders involved in militancy-related cases.

Many terror cases, including the 1990 killing of Kashmiri Pandit Sarwanand Koul Premi, who was a Kashmiri poet, journalist, research scholar, Gandhian, social reformer and independence activist and his young married son, Verinder, have been reopened, investigated and killers identified.

Two workers killed as blaze engulfs fireworks factory

Two workers were killed after a powerful explosion triggered a major fire at a licensed fireworks factory near Sivakasi in Tamil Nadu's Virudhunagar district on Thursday, officials said.

The accident occurred at the manufacturing unit in Namaskarithanpatti while employees were engaged in production work.

The explosion sparked a fire that rapidly spread through parts of the premises, sending smoke into the air and causing panic in the area.

The two workers suffered fatal injuries and died at the scene. Their identities were not immediately released.

There was no confirmation of other casualties. Fire and Rescue Services

personnel rushed to the factory after being alerted and launched an operation to contain the blaze. Firefighters continued to douse the flames and cool the affected structures amid concern over explosive material stored inside the unit.

Police and revenue officials also reached the site and secured the surrounding area to prevent residents and onlookers from approaching the factory. Police registered a case and began an investigation into the circumstances that led to the explosion.

Officials are expected to examine whether prescribed safety procedures were followed, how chemicals and finished fireworks were stored, and whether production was being carried out within the conditions of the factory's licence.

Nurse found dead in washroom of state-run hospital in Kolkata

A nurse was found dead in a washroom of the state-run NRS Medical College and Hospital in Kolkata, hours after she joined duty, the police said on Thursday.

The police have started an investigation into her death, while the health department also formed a separate team to probe into the matter.

Health Minister Dr Sharad-wat Mukherjee visited the hospital on Thursday morning and spoke to those on duty with her the previous night.

The 30-year-old nurse was on night duty at the hospital's high-dependency unit (HDU) on Wednesday.

According to the preliminary investigation, she reported for duty around 8 pm and went to the staff washroom at the antenatal ward in the Gynaecology Department Building around 10.30 pm, police said.

"When she did not return for some time, her colleagues went to check on her and found the washroom door locked. After repeated knocks drew no response, two of

them broke open the door and found her lying unconscious on the floor," a police officer said.

A doctor was called to examine the nurse, and she was subsequently declared dead, he said.

Personnel from Entally police station, along with officers of the Detective Department's Homicide team, reached the hospital after being informed about the incident, the officer said.

The preliminary investigation found no visible injury marks on the body, and no suicide note was recovered, he said.

Several medicine vials were reportedly found near her body, prompting investigators to examine whether she had taken the vials with her to the washroom while on duty.

"We suspect that the nurse may have died following an overdose of an anaesthetic drug administered through an injection. However, our detectives are investigating all angles," he said.

The police officer said that the deceased was known among her colleagues and patients for her cheerful nature.
