Pursuant to Regulation 30, we wish to inform you that Central Railway vide its letter dated 4<sup>th</sup> August, 2025 has awarded an order of Rs. 73.12 crore for Design, Supply, Erection, Testing and Commissioning of 110 KV/25KV AC Traction Substation, SSP and associated works to be executed over a period of 24 months. This order is the composite order for 132/25 Kv Traction Sub Station along with incoming supply provision including modification to 132 KV transmission line using HTLS conductor to provide incoming supply to the traction substation.
